IT IS RESOLVED by the Duluth Parking Commission to extend the no parking setback from a driveway at approximately 1100 East 2<sup>nd</sup> Street from the 7' default to 50' for sightline and safety reasons and to add one single-space parking meter just beyond that point.

**STATEMENT OF PURPOSE:**

This action serves to enhance safety by providing clearer sightlines for traffic entering the roadway from the lot served by the driveway and adds one meter to align the remaining parking configuration with the adjacent area.


*To install an ADA parking space at 612 North 57<sup>th</sup> Avenue West.*
