- **4. Accessible Parking Update** Mr. Bauer reports accessible parking has become more prevalent and a high level of conversation at recent Parking Commission meeting on Feb 1. Mr. Bauer submitted the following verbal report: Recommended by Mr. Bauer and Approved by Parking Commission:
 - 3506 West 2nd Street, 628 N 60th Ave W, 107 S 19th Ave W, 13302 W 3rd
 - 231 E 8th St, 615 N 58th Ave W, 2108 W 1st St, 326 N 23rd Ave W, 505 N 57th Ave W
 - 1525 Jefferson Street this signage will be removed as tenant moved
 - East 2nd Street (address not noted) 10 minute drop off zone created

Ordean Building Accessible Parking - Mr. Bauer shared he has no clear answer from city engineers on liability and installing ADA on Superior Street. Mr. Crawford echoed agreement that he believes the issue is stuck between engineers and LHB contractors – dialogue with Commission includes keeping the issue on the agenda. In regards to ADA parking on Michigan, Mr. Bauer shared curb is too high and grade is of concern to install proper ADA but engineering is expected to install 2 ADA spots on Michigan with time limit (4 hours) as currently one ADA with no time limit is in place. This conversation will continue and shared with Commission by Mr. Bauer and Mr. Crawford as it develops.

6. Old Business

Event Checklist – Mr. Crawford reports printing is done and checklists are now at city office. Mr. Crawford posed a dilemma of how does the Commission follow up to ensure meeting the recommendations and what does the Commission want? Ms. Burke asked if city permit personnel could attend Commission meeting in the future – Ms. Berner asked if language could be included on checklist and permit involving "if Q's, contact Commission". Mr. Crawford will inquire within the city department.

He also shared the topic of individuals with mental health diagnoses and the interactions with law enforcement are a topic that is presenting itself in the area.
