The regular meeting of the Alcohol, Gambling & Tobacco Commission was held on Wednesday, January 6, 2016, at 4:45 p.m., in the City Council Chamber, 3rd Floor, City Hall.

The minutes of the November 4, 2015, Alcohol, Gambling and Tobacco Commission meeting were unanimously approved.

NEW BUSINESS:

HISTORIC UNION DEPOT, INC. (SLC HERITAGE & ARTS CENTER), 506 W. MICHIGAN ST – APPLICATION FOR PERMANENT EXPANSION OF THE ON SALE INTOXICATING LIQUOR LICENSE AND ON SALE DANCING LICENSE FOR THE PERIOD ENDING AUGUST 31, 2016.

Ken Buehler was present on behalf of the application. Mr. Buehler explained that they would like to make the areas that they use for alcohol service during the Mayor's Pride Reception every fall a permanently licensed area so they don't have to keep coming back to the city each year. He continued saying that they don't anticipate using those areas during the course of the year and don't plan on having tables and chairs in that area other than the fall, but would like to have the opportunity to do so on a short notice. To questioning from the commission, Mr. Buehler replied there is fencing around the back platform which will be easy to police. The clerk reviewed that if were to use the front sidewalk area at any other time during the year, it would have to sectioned off by fencing and that security would need to be in place for that event. Officer Vang stated he has approved the application. There being no further discussion, Mr. Birchland moved that THE APPLICATION OF HISTORIC UNION DEPOT, INC. (SLC HERITAGE & ARTS CENTER), 506 W. The commission discussed the issue and moved to request the City Attorney's office send a Notice of Hearing to the licensee of Spurs on 1st and Aces Bar. The motion was approved unanimously.

There being no further business to bring before the commission, the meeting was declared adjourned at 5:03.



PLEASE BE ADVISED that on **March 2, 2016**, at **4:45 p.m.** in the Council Chambers at City Hall in the City of Duluth, the Duluth Alcohol, Gambling and Tobacco Commission will hold a hearing, pursuant to Minnesota Statutes §340A.415 and Section 8-9 of the Duluth City Code, to consider what, if any, disciplinary action, including suspension or revocation or a civil fine of not to exceed \$2,000, will be recommended to the Duluth City Council with respect to your intoxicating liquor license.

If you do not appear at said hearing, the Alcohol, Gambling and Tobacco Commission may, in your absence, recommend that the Duluth City Council consider the allegations contained herein to be true.

At the above-mentioned hearing, you may, at your option, be represented by legal counsel.

The Rules for Contested Case Hearings, Minnesota Rules Chapter 1400, Part 5550, et.seq, to the extent applicable, and Minnesota Statutes §14.57 through §14.69 govern. Copies of these laws and rules may be obtained at the Duluth Public Library or online from the official web site of the State of Minnesota.

The City will present its case, and then you will have an opportunity to present your case. At the time of the hearing, you should be prepared to produce any evidence and arguments you feel are relevant to the issues raised. You or your attorney will be allowed to cross-examine all adverse witnesses. If needed, subpoenas are available (Minnesota Rules 1400.7000).

You must advise the Commission if you seek to admit evidence that is classified not public. If data that is not public is admitted, it may become public. Relief is available under Minnesota Statutes §14.60, subd. 2. If an interpreter is needed, you must inform the Commission and one will be appointed.

A notice of appearance must be filed with the City Clerk within 20 days of the date of service of the notice of hearing if you intend to appear at the hearing unless the hearing date is less than 20 days from the issuance of the notice of hearing.

The hearing will be open to the public.

The following facts give rise to the inquiry and hearing mentioned above:

1. HOSPITALITY ASSOCIATES OF DULUTH, LLC, d/b/a Aces on First, is licensed by the City of Duluth to sell intoxicating liquor "on-sale" at the premises located at 113 West 1st Street, Duluth, Minnesota 55802.
2. Licensee has failed to timely file state sales tax returns and/or has failed to timely pay state sales taxes. Any business with a liquor license ("Licensee") who is ten days or more delinquent in either filing a state sales tax return or paying the tax is posted on a list generated by the Minnesota Department of Revenue. *See* Minn. Stat. §270C.725. A Licensee cannot purchase liquor, beer or wine for resale after being placed on the list. The Minnesota Department of Revenue notifies the Licensee at least ten days before they are posted on the Tax Delinquency list. Minn. Stat. §270C.725, subd. 1. Beginning the third business day after the list is posted, no wholesaler, manufacturer, or brewer may sell or deliver any product to a Licensee on the list. Minn. Stat. §270C.725, subd. 2. (A copy of Minn. Stat. §270C.725 is attached as City Document Number 1).
3. Licensee has engaged in a pattern of failing to timely file its state sales tax returns and/or pay its state sales tax obligations. Licensee was posted on the Minnesota Department of Revenue tax delinquent liquor posting for the following time periods in 2015: January 2015 through February 2015 (two months); June 2015 through

September 8, 2015 (over three months); and November 2015 through and continuing to the date of the last report that was run on 01/27/2016 (three months). (A copy of the Minnesota Department of Revenue Liquor Posting List dated January 27, 2016 at 7:00 p.m. is attached as City Document Number 2. Licensee's name appears near the bottom of page 4).

4. In addition to state sales taxes, Licensee is required to collect a 1% city sales tax on retail sales. See Duluth City Code chapter 42A. (A copy of Duluth City Code §42A-2 is attached as City Document Number 3). Under current state law, this 1% local sales tax is reported and paid to the Minnesota Department of Revenue with the state sales taxes as required by chapter 297A of the Minnesota Statutes. That is, the Department of Revenue collects all sales taxes and then remits the city sales tax to the city of Duluth.
5. For each month that a Licensee fails to timely file a state sales tax return and submit payment of the taxes, it necessarily means that the Licensee is also late in paying the city of Duluth's 1% sales tax that is collected by the state.
6. Section 8-9(b)(3) provides that failure to pay city or state sales taxes shall be deemed good cause for suspension or revocation of a liquor license.
7. This is the Licensee's first violation for purposes of the presumptive penalty schedule provided for in Duluth City Code section 8-9.
8. Section 8-9 (c) provides that "No portion of the payment of a civil penalty or period of suspension may be stayed or excused. All civil penalties are due and payable within 30 days of council action. The council shall determine the dates any suspension shall be served, but in no event may the suspension period commence earlier than ten days after council action."
9. Section 8-9(c) further provides that "Absent aggravating or mitigating circumstances, the presumptive penalties for violations shall be as follows: (1) First offense - a civil penalty set in accordance with Section 31-8 of this Code."
10. The civil penalty set in accordance with Section 31-8 of this Code for a first offense is a \$500 penalty.

Pursuant to City Code Sections 8-9(a) and (b) the Alcohol, Tobacco and Gambling Commission will consider whether the violation alleged is good cause for suspension or revocation of the liquor license or for the imposition of a civil penalty.

The commissioner is under no obligation to list a taxpayer whose business is inactive. At least ten days before notifying the commissioner of public safety, the commissioner shall notify the taxpayer of the intended action.

The commissioner of public safety shall post the list in the same manner as provided in section 340A.318, subdivision 3. The list will prominently show the date of posting. If a taxpayer previously listed files all returns and pays all taxes specified in this subdivision then due, the commissioner shall notify the commissioner of public safety within two business days.

Subd. 2. **Sales prohibited.** Beginning the third business day after the list is posted, no wholesaler, manufacturer, or brewer may sell or deliver any product to a taxpayer included on the posted list.

Subd. 3. **Penalty.** A wholesaler, manufacturer, or brewer of intoxicating liquor or 3.2 percent malt liquor who violates subdivision 2 is subject to the penalties provided in section 340A.304.

Sec. 42A-2. Sales tax--imposed; amount of tax; exemptions.

(a) To provide funds for the purpose of general municipal operations, maintenance and capital improvements of the city, there shall be and is hereby imposed an excise tax of one percent on gross receipts of any person from sales at retail, including the sales of motor vehicles, as defined in this Chapter, made in the city. In no case shall the tax imposed hereby upon the seller exceed the amount of the tax which he is authorized and required by law to collect from the purchaser. Except in the case of motor vehicles and as otherwise provided in this Section, all goods and services that are exempt from taxation under the provisions of Minnesota Statutes Chapter 297A are exempt from taxation under this Chapter;

(b) In addition to the tax set forth in Subsection (a) of this Section, and notwithstanding any provision of law to the contrary, an additional tax of two and one-quarter percent is hereby imposed on gross receipts from the furnishing, preparing or serving for a consideration of food, meals or drinks, not including those prepared and served at hospitals, sanatoriums, nursing homes or senior citizens' homes, meals or drinks purchased for and served exclusively to individuals who are 60 years of age or over and their spouses or to the handicapped and their spouses by governmental agencies, nonprofit organizations, agencies or churches or pursuant to any program funded in whole or in part through 42 USCA Sections 3001 through 3045, wherever delivered, prepared or served, meals and lunches served at public and private schools, universities or colleges, or the occasional meal thereof by a charitable or church organization. The tax imposed in this Subsection is subject to the exemptions set forth in Subsection (c) of this Section and to the limitations of Laws of Minnesota 1980, Chapter 511, as amended;

(c) The tax imposed by Subsection (b) above shall not be imposed:

(1) Upon business establishments doing less than \$100,000 in sales taxable under Subsection (b) in any current tax period from October 1 to September 30 of the next year;

(2) Upon business establishments which did less than \$100,000 in sales taxable under Subsection (b) in any current tax period from October 1 to September 30 immediately preceding the period from October 1 to September 30 in which the tax would be collected;

(d) New establishments. The exemption in Subsection (c)(2) above shall not apply to newly opened establishments or establishments which have not been in operation for one year on September 30. In the case of the above-mentioned establishments, the administrator shall make an estimate of the anticipated yearly sales volume of the establishment based on the size, type of operation, sales volume of similar establishments in the area and any other available relevant data. If the estimated yearly sales volume exceeds \$100,000, the establishment shall collect and remit the tax authorized in Subsection (b). If the establishment has not reached \$100,000 in sales taxable under Subsection (b) by the next September 30, taxes remitted by the establishment pursuant to Subsection (b) shall be refunded to the establishment in the manner provided in Section 42A-35 of this Chapter;

(e) Notwithstanding the provisions of paragraph (a) of this Section, for sales at retail of manufactured homes used for residential purposes the excise tax is imposed upon 65 percent of the sales price of the home. (Ord. No. 7725, 8-11-1969, § 2; Ord. No. 8332, 6-20-1977, § 1; Ord. No. 8541, 10-14-1980, § 2; Ord. No. 8962, 11-20-1989, § 2; Ord. No. 9372, 5-26-1998, § 1; Ord. No. 9433, 12-20-1999, § 2; Ord. No. 9908, 5-12-2008, §1.)

===== NARRATIVE =====

On September 10, 2015 at 1100 hours I was contacted by Deputy Chief Mike Tusken and asked to investigate a possible violation of a liquor license at the Ace's on First establishment located at 113 West 1st Street, Duluth, MN 55802. Tusken emailed a police report which was completed by officer Huot # 464 under this same case number (15198250). I read the report completed by Officer Huot in which it states that on September 4, 2015 at 2217 hours, Officer Huot went into the Aces on First to investigate a communication I placed on September 3, 2015 at 1003 hours for the patrol squads to check on this establishment because they did not currently have a liquor license as it expired on August 31, 2015 at midnight. Officer Huot verified on September 4, 2015 that Aces on First was indeed open and serving alcoholic beverages. Refer to Officer Huot's report for further details.

I, Officer Vang working in my capacity as the Licensing Officer for the Duluth Police Department, was informed at the August 2015 monthly meeting of the Alcohol, Gambling and Tobacco Board Commission that the city clerk received notice from the State of Minnesota that they has not cleared Hospitality Associates of Duluth, LLC DBA Aces on First to receive their liquor license for the new period beginning September 1, 2015. The City of Duluth cannot issue a liquor license if an establishment owes taxes and so forth to the State or the City. A letter dated August 7, 2015 was sent to Ace's on First from the city attorney's office "that the city will be unable to issue licenses to Aces for the period beginning September 1, 2015 unless the State of Minnesota ("State") issues a clearance certificate, and all City conditions for licensure are satisfied", Ace's on First will be unable to operate as a bar and dancing establishment or have alcohol on its property after August 31, 2015 at midnight.

On September 3, 2015 at 0959 hours, I called 218-348-4358 a contact phone number for NICK PATRONAS who is the owner of the business.. I did not receive an answer and as I was leaving a message for NICK PATRONAS I saw on my caller ID that he was calling me back. I hung up and answered the incoming call and spoke with NICK PATRONAS. I asked PATRONAS if he had received a letter from the City Attorney's Office and he said that he did. I had a copy of the letter in front of me and reiterated it, the fact that Aces on First did not have a liquor license and that Ace's was not to be open after August 31, 2015. PATRONAS told me that he has not been open and will not be open until he receives a clearance letter from the State and a City liquor license. After hanging up the phone with PATRONAS, I put a communication to the patrol squads to check Aces on First because they currently do not have a liquor license.

I checked with the City Clerk's Office on Tuesday September 8, 2015 to see if they received the clearance certificate from the State of Minnesota and they informed me via email on Wednesday September 9, 2015 that they received the clearance certificate from the State of Minnesota for Hospitality Associates of Duluth (Ace's on First) dated September 8, 2015. Due to the fact that the violation occurred on 09/04/2015 and the clearance letter from the MN Department of Revenue was dated 09/08/2015 and the city had yet to issue Ace's on First a liquor license, a citation for Unlicensed Sale in violation of Duluth City Code 8-21 was mailed to Hospitality Associates of Duluth LLC operating as Aces on First 220 West Superior Street. A copy of the letter from the MN Department of Revenue dated 09/08/2015 and a letter from the City Attorney's Office dated 08/07/2015 is attached.

PLEASE BE ADVISED that on **March 2, 2016, at 4:45 p.m.** in the Council Chambers at City Hall in the City of Duluth, the Duluth Alcohol, Gambling and Tobacco Commission will hold a hearing, pursuant to Minnesota Statutes §340A.415 and Section 8-9 of the Duluth City Code, to consider what, if any, disciplinary action, including suspension or revocation or a civil fine of not to exceed \$2,000, will be recommended to the Duluth City Council with respect to your intoxicating liquor license.

If you do not appear at said hearing, the Alcohol, Gambling and Tobacco Commission may, in your absence, recommend that the Duluth City Council consider the allegations contained herein to be true.

At the above-mentioned hearing, you may, at your option, be represented by legal counsel.

The Rules for Contested Case Hearings, Minnesota Rules Chapter 1400, Part 5550, et.seq, to the extent applicable, and Minnesota Statutes §14.57 through §14.69 govern. Copies of these laws and rules may be obtained at the Duluth Public Library or online from the official web site of the State of Minnesota.

The City will present its case, and then you will have an opportunity to present your case. At the time of the hearing, you should be prepared to produce any evidence and arguments you feel are relevant to the issues raised. You or your attorney will be allowed to cross-examine all adverse witnesses. If needed, subpoenas are available (Minnesota Rules 1400.7000).

You must advise the Commission if you seek to admit evidence that is classified not public. If data that is not public is admitted, it may become public. Relief is available under Minnesota Statutes §14.60, subd. 2. If an interpreter is needed, you must inform the Commission and one will be appointed.

A notice of appearance must be filed with the City Clerk within 20 days of the date of service of the notice of hearing if you intend to appear at the hearing unless the hearing date is less than 20 days from the issuance of the notice of hearing.

The person representing the City, who you should contact to discuss settlement or other concerns is Terri L. Lehr, Assistant City Attorney.

The hearing will be open to the public.

The following facts give rise to the inquiry and hearing mentioned above:

1. THE DUKES PARTNERS, LLC, d/b/a Spurs on 1st, is licensed by the City of Duluth to sell intoxicating liquor "on-sale" at the premises located at 109 West 1st Street, Duluth, Minnesota 55802.
2. Licensee has failed to timely file state sales tax returns and/or has failed to timely pay state sales taxes. Any business with a liquor license ("Licensee") who is ten days or more delinquent in either filing a state sales tax return or paying the tax is posted on a list generated by the Minnesota Department of Revenue. See Minn. Stat. §270C.725. A Licensee cannot purchase liquor, beer or wine for resale after being placed on the list. The Minnesota Department of Revenue notifies the Licensee at least ten days before they are posted on the Tax Delinquency list. Minn. Stat. §270C.725, subd. 1. Beginning the third business day after the list is posted, no wholesaler, manufacturer, or brewer may sell or deliver any product to a Licensee on the list. Minn. Stat. §270C.725, subd. 2. (A copy of Minn. Stat. §270C.725 is attached as City Document Number 1).
3. Licensee has engaged in a pattern of failing to timely file its state sales tax returns and/or pay its state sales tax obligations. Licensee was posted on the Minnesota Department of Revenue tax delinquent liquor posting for the following time periods in 2015: February 2015 (one month); July 2015 (one month); August 2015 (from

8/1/15 through 8/20/15); October 2015 through and continuing to the date of the last report that was run on 01/27/2016. (A copy of the Minnesota Department of Revenue Liquor Posting List dated January 27, 2016 at 7:00 p.m. is attached as City Document Number 2. Licensee's name appears near the bottom of page 4).

4. In addition to state sales taxes, Licensee is required to collect a 1% city sales tax on retail sales. *See* Duluth City Code chapter 42A. (A copy of Duluth City Code §42A-2 is attached as City Document Number 3). Under current state law, this 1% local sales tax is reported and paid to the Minnesota Department of Revenue with the state sales taxes as required by chapter 297A of the Minnesota Statutes. That is, the Department of Revenue collects all sales taxes and then remits the city sales tax to the city of Duluth.
5. For each month that a Licensee fails to timely file a state sales tax return and submit payment of the taxes, it necessarily means that the Licensee is also late in paying the city of Duluth's 1% sales tax that is collected by the state.
6. In addition to the 1% city sales tax on retail sales, there is also a 2.25% food and beverage tourism tax ("tourism tax") that is imposed by Chapter 42A of the Duluth City Code. Licensees are required to report the sales for this tax on a Tourism Tax Return Form. This Tourism Tax Return Form is filed with the city of Duluth and the tax due is paid directly to the city of Duluth. Pursuant to §42A.26 of the Duluth City Code, sales taxes "shall be due and payable" on a monthly basis. Monthly payments are due "on or before the 20th day of the month" following the month in which the sales occurred. For example, taxes collected on sales made in the month of January 2015 are due and payable on or before February 20, 2015.
7. Licensee has failed to pay the city of Duluth food and beverage tourism taxes for the sales that occurred in October of 2015. Licensee filed this Tourism Tax Return Form with the city and it was entered into the city of Duluth's sales tax system on November 23, 2015. According to the Tourism Tax Return Form, Licensee owed \$732.76 in tourism taxes in connection with the October 2015 sales. Licensee

- tendered payment of these tourism taxes by check number 099 dated 11-16-15 in the amount of \$732.76. (A copy of this check is attached as City Document Number 4).
8. On December 7, 2015, the above check was returned unpaid to the city treasurer's office due to non-sufficient funds ("NSF"). (Attached as City Document Number 5 is a copy of the statement from Wells Fargo showing non-payment of this check.)
 9. On December 9, 2015, Ruthann Grace, Administrator of Credit and Collections for the city of Duluth, authored a letter to the Licensee advising that the check for the October tourism taxes was returned by the bank as NSF. This letter further advised that payment \$762.76, which sum includes the outstanding taxes together with the returned check fee, must be paid by December 29, 2015. Finally, this letter advised the Licensee that failure to pay city or state sales tax **shall be deemed good cause for suspension or revocation of a liquor license**. This letter was served upon the Licensee via U.S. Mail and email on December 29, 2015. (A copy of the letter sent to the Licensee is attached as City Document Number 6).
 10. On December 9, 2015, Ruthann Grace received a response to her email. The response was from Nick G. Patronas and indicated that, "On Monday, I will make new check, and send out." (A copy of this email communication is attached as City Document Number 7).
 11. Ruthann Grace did not receive a check from the Licensee on the following Monday, December 14, 2015, nor had she received any payment as of December 21, 2015.
 12. On December 21, 2015, Ruthann Grace debited the check amount back onto the Licensee's account and assessed all applicable penalties and interest on the outstanding balance. On the same day, she also authored a letter to the Licensee giving him notice that the city of Duluth was filing a claim for Revenue Recapture with the Minnesota Department of Revenue. (A copy of this letter is attached as City Document Number 8).
 13. On January 1, 2016, a notice was generated by the city of Duluth reflecting the outstanding tax, penalty and interest in the amount of \$898.89. This notice was

mailed to the Licensee on January 5, 2016. (A copy of this notice is attached as City Document Number 9).

14. As of January 28, 2016, no payment has been received from the Licensee and the full amount of the tourism taxes stemming from Licensee's October 2015 sales remain due and owing, together with penalty and interest.
15. As of January 28, 2016, Licensee has failed to make good on the NSF check that he issued to the city on 11-16-15.
16. Section 8-9(b)(3) provides that failure to pay city or state sales taxes shall be deemed good cause for suspension or revocation of a liquor license.
17. This is the Licensee's first violation for purposes of the presumptive penalty schedule provided for in Duluth City Code section 8-9.
18. Section 8-9 (c) provides that "No portion of the payment of a civil penalty or period of suspension may be stayed or excused. All civil penalties are due and payable within 30 days of council action. The council shall determine the dates any suspension shall be served, but in no event may the suspension period commence earlier than ten days after council action."
19. Section 8-9(c) further provides that "Absent aggravating or mitigating circumstances, the presumptive penalties for violations shall be as follows: (1) First offense - a civil penalty set in accordance with Section 31-8 of this Code."
20. The civil penalty set in accordance with Section 31-8 of this Code for a first offense is a \$500 penalty.

Pursuant to City Code Sections 8-9(a) and (b) the Alcohol, Tobacco and Gambling Commission will consider whether the violation alleged is good cause for suspension or revocation of the liquor license or for the imposition of a civil penalty.

270C.725 POSTING OF TAX DELINQUENCY; SALE OF LIQUOR OR BEER.

Subdivision 1. **Posting, notice.** Pursuant to the authority to disclose under section 270B.12, subdivision 4, the commissioner shall, by the 15th of each month, submit to the commissioner of public safety a list of all taxpayers who are required to pay, withhold, or collect the tax imposed by section 290.02, 290.0922, 290.92, 290.9727, 290.9728, 290.9729, or 297A.62, or local sales and use tax payable to the commissioner, or a local option tax administered and collected by the commissioner, and who are ten days or more delinquent in either filing a tax return or paying the tax.

The commissioner is under no obligation to list a taxpayer whose business is inactive. At least ten days before notifying the commissioner of public safety, the commissioner shall notify the taxpayer of the intended action.

The commissioner of public safety shall post the list in the same manner as provided in section 340A.318, subdivision 3. The list will prominently show the date of posting. If a taxpayer previously listed files all returns and pays all taxes specified in this subdivision then due, the commissioner shall notify the commissioner of public safety within two business days.

Subd. 2. **Sales prohibited.** Beginning the third business day after the list is posted, no wholesaler, manufacturer, or brewer may sell or deliver any product to a taxpayer included on the posted list.

Subd. 3. **Penalty.** A wholesaler, manufacturer, or brewer of intoxicating liquor or 3.2 percent malt liquor who violates subdivision 2 is subject to the penalties provided in section 340A.304.

Sec. 42A-2. Sales tax--Imposed; amount of tax; exemptions.

(a) To provide funds for the purpose of general municipal operations, maintenance and capital improvements of the city, there shall be and is hereby imposed an excise tax of one percent on gross receipts of any person from sales at retail, including the sales of motor vehicles, as defined in this Chapter, made in the city. In no case shall the tax imposed hereby upon the seller exceed the amount of the tax which he is authorized and required by law to collect from the purchaser. Except in the case of motor vehicles and as otherwise provided in this Section, all goods and services that are exempt from taxation under the provisions of Minnesota Statutes Chapter 297A are exempt from taxation under this Chapter;

(b) In addition to the tax set forth in Subsection (a) of this Section, and notwithstanding any provision of law to the contrary, an additional tax of two and one-quarter percent is hereby imposed on gross receipts from the furnishing, preparing or serving for a consideration of food, meals or drinks, not including those prepared and served at hospitals, sanatoriums, nursing homes or senior citizens' homes, meals or drinks purchased for and served exclusively to individuals who are 60 years of age or over and their spouses or to the handicapped and their spouses by governmental agencies, nonprofit organizations, agencies or churches or pursuant to any program funded in whole or in part through 42 USCA Sections 3001 through 3045, wherever delivered, prepared or served, meals and lunches served at public and private schools, universities or colleges, or the occasional meal thereof by a charitable or church organization. The tax imposed in this Subsection is subject to the exemptions set forth in Subsection (c) of this Section and to the limitations of Laws of Minnesota 1980, Chapter 511, as amended;

(c) The tax imposed by Subsection (b) above shall not be imposed:

(1) Upon business establishments doing less than \$100,000 in sales taxable under Subsection (b) in any current tax period from October 1 to September 30 of the next year;

(2) Upon business establishments which did less than \$100,000 in sales taxable under Subsection (b) in any current tax period from October 1 to September 30 immediately preceding the period from October 1 to September 30 in which the tax would be collected;

(d) New establishments. The exemption in Subsection (c)(2) above shall not apply to newly opened establishments or establishments which have not been in operation for one year on September 30. In the case of the above-mentioned establishments, the administrator shall make an estimate of the anticipated yearly sales volume of the establishment based on the size, type of operation, sales volume of similar establishments in the area and any other available relevant data. If the estimated yearly sales volume exceeds \$100,000, the establishment shall collect and remit the tax authorized in Subsection (b). If the establishment has not reached \$100,000 in sales taxable under Subsection (b) by the next September 30, taxes remitted by the establishment pursuant to Subsection (b) shall be refunded to the establishment in the manner provided in Section 42A-35 of this Chapter;

(e) Notwithstanding the provisions of paragraph (a) of this Section, for sales at retail of manufactured homes used for residential purposes the excise tax is imposed upon 65 percent of the sales price of the home.
