2.Duluth Arts Network- Tony Cuneo (Zeitgeist Arts) & Sarah Lawrence (Lyric of the Opera North)

Guests Tony Cuneo and Sarah Lawrence (members of Duluth Arts Network) spoke to commissions members regarding funding for arts organizations within Duluth. The group is looking to find new ways of specific financial support from the City of Duluth for arts organizations. The first step could potentially be working with the City's partners marketing partners (such as Visit Duluth) to work on a long-term arts & cultural marketing effort. The second step would be requesting a direct line item of one million dollars from the City's general fund for art organization's funding. Commissioners asked questions of the presenters. DAN would like to be

involved with further conversations regarding funding. The Creative Watershed subcommittee will discuss this further.
