3. Superior Street Subcommittee Update

7. DECC Northland Streams

McElray Hunter discussed the maintenance subcommittee is looking for the warranty on the panels and the group was wondering if the DECC can help advocate for the warranty with the manufacturer. McElray Hunter will be in contact with the artist if there is additional information regarding this or pictures he can share. Broadwell said the DECC most likely has quite a bit of information in their files and that they could likely assist in helping us to warranty it. Bacso shared she could not locate any information regarding the warranty of the panels in the DPAC files.

8. De-accessioning ceremony

Woods asked what does DPAC do when we de-accession a statue or any artwork that is failing, no longer able to be maintained or a narrative that does not fit. One thought is once the pieces are de-accessioned, they could continue on in a digital archive. The ceremony would be open to

the public and would help people process change. DPAC could host listening sessions on what the community thinks about a piece of art to create an open process. This process would help to make room for other narratives and the future community that will live in Duluth. Woods shared that the next step is to put this in a committee explore this further and come up with a plan that can be brainstormed. The maintenance subcommittee would take it on.

9. Creative watershed ad-hoc subcommittee work session

Gilpin share the subcommittee had a good discussion on the Creative Watershed document and what the process should be to approach it. Woods would like everyone on the commission to decide what section of the Creative Watershed plan they would like to work on and what resonates with them (4.1-4.5). Commissioners can group up on these sections and would invite the leadership identified in these sections and would come up with a plan for priorities. Woods requested commissioners send Bacso what area they are interested in.

10. DPAC logo and branding

Maintenance subcommittee is ready to launch events on social media and share art swag. The group could do stickers with a DPAC logo or Duluth Public Arts Commission logo under it. Woods like the idea formatted for a banner on Facebook. Broadwell asked commissioners to email her if you have any swag idea that DPAC can look into. Another idea was to collect different pins of different public works.
