Subcommittee Reports

1. Festivals and Performances

Cold Front at the DECC:

Discussion: Desire for the light display projected at the DECC during the event. Either on Lake side or Highway side.

Demmer: Zeitgeist has been talking about Cold Front is same day as Transportation Equity day, and goal of making Cold Front more accessible. However, Bayfront is the closest transit stop and it is a few blocks away (or Canal, but still need to cross over highway). Light projected on the Highway side could be a way for the light display to welcome people in.

Tammy and Carly will work together to coordinate outreach to the DECC on remaining questions:

• How long would the display be up?

Cold Front goes until 6pm, and sunset is at 5:15pm.

- Does the DECC require money for this?
- Discussion on which side the light should be projected:
 - Opportunity to have it on the Highway side could have more people viewing
 - Discussion: Any requirements on the size of projection, what type of generator etc.?
- Who is paying for the van to run the projection?
 - Woods: There is a grant through Minnesota Power to fill out if we want apply for up to \$5k.

REQUEST: Going forward at these meetings can we have the budget in front of us each month?

Discussion on using the wall on the Electric Fetus wall for display in the future. Desire to have the light display at this site in the future as it is more accessible and better for activating the downtown.

Carly will contact Eleanor to get in touch with MN Power in order to get on board with this.

Suggestion on doing both (projection at the DECC as well as the Electric Fetus wall), and having two vans.

Are there other events happening at the same time? If so, discussion on an opportunity to go around and walk through to multiple events.
