## I. Opening Remarks & Welcoming Guests (5:00 pm)

Annalisa Peterson with Duluth Cross-Country Ski Club provided an overview of the work at Spirit Mountain for the Grand Avenue Nordic Center, referencing the proposed ski trails, lighting and snow making possibilities. Explained the role of the City of Duluth and the necessity of a strong partnership in moving the project forward.

#### C. Lincoln Park – Ecolibrium3 (6:08 pm)

Jodi Slick with Ecolibrium3 presented on the successes at Lincoln Park and the importance of establishing a strong partnership with the City of Duluth. Provided an overview of the Mini-Master Plan for Lincoln Park and updated group on the mission of Ecolibrium3.

Mike Casey: Spoke on behalf of Friends of West Duluth Parks and Trails, thanking City Staff for their work and extending his appreciation for their time and hard work.
