## I. Opening Remarks & Welcoming Guests (5:00 pm)

Glen Nelson: Stated gratitude towards the City on a great job maintaining the ski trail. Stated the amount of use the trail receives. Asked if the City could take a corridor of the trail to make into a park.

Joel Tracy: Thanked Tony Dierckins for his presentation, as well as the dedication spent by Parks Commissioners. Stated concern on the decision making process for Lower Spirit. Stated he would like to know how William Roche and the City Administration plan to address improving

Gail Kernzin: Stated the amount of foot travel on Park Point. Expressed the sanitary concern of users not using bathroom facilities. Stated an appreciation for staff who maintain Enger Park.
