Staff: Director Fleege indicated this opportunity was brought to City Staff last week. Boresight toured the MRO facility previously and reached out last week to discuss the potential to lease the facility if they are selected for work that would require a sizeable facility like the MRO. Introduced CEO of Boresight, Brad Bullard.

Brad Bullard indicated they are seeking to do F16 plane maintenance that is typically done by Air force members, but this is an opportunity for them. This lease is dependent on them successfully being chosen after bid decision made.

Bob Asleson indicated that they do not have a contract and the lease is contingent upon Boresight giving notice that they are successful in getting the bid. The lease would in effect terminate if not selected. There are a great deal of unknowns, but part of the bid process was Boresight showing they had a facility to lease should they be selected.

Discussion: Commissioner Filipovich thanked Mr. Bullard for his time and expressed excitement and appreciation for this type of work at the MRO facility. Wished Boresight the best of luck in securing the contract.
