Harbor Plaza Preliminary Design (Informational) Cliff Knettel, Senior Planner

Crosby shared the Commission on Disabilities expressed the importance of having accessible parking available. Knettel indicated there will likely not be drive up availability along the harbor, but designated handicapped areas will be installed in the formal parking area.

Rohrbaugh shared the open house meeting was a major success. Questioned where the designated stage area will be for bands to play. Knettel indicated there is discussion between two spots. Rohrbaugh suggested to have the lift bridge as the background as the view for the audience.

Chin questioned what was decided on the paddling access. Knettel shared this will likely happen during a separate phase due to funding constraints. Indicated it's sought out asset, but funding would need to be available.

Peterson questioned if there could be signage to have walkers use the boardwalk vs. the paved path to reduce conflicts with bikes. Stated it would be nice to have a paddling access in Canal Park from the William A Irvin Ship. Knettel shared Vista Fleet allows access from their dock. Shared the City will use it's signage package and will review opportunities for walkers to utilize the boardwalk and bikes to use the paved trail.
