Notice is hereby given that Online Bids will be received by the City of Duluth, on behalf of the Duluth Airport Authority, until 2:00 p.m., Tuesday, March 8, 2022. Bids may be submitted electronically through Bid Express® at www.bidexpress.com, for the furnishing of all labor and material for the construction of Runway 3-21 Lighting and Signage Replacement. The City Purchasing Agent will conduct a public bid opening via webex livestream, immediately after the deadline for receiving bids. Major components of the Work include: installation of 49 LED medium intensity runway edge lights, installation of 16 LED medium intensity runway threshold lights, installation of 7 LED runway distance remaining signs, installation of 11 LED runway hold short signs, approx. 26,000 LF installation of cable, installation of PVC conduit, installation of directional bored electrical conduit, installation of Runway End Identifier Lights, and installation of a constant current regulator in the airfield electrical vault.
