# Addendum 1 Solicitation 22-99400 Lift Station 17 Generator and Control Panel

This addendum serves to notify all bidders of the following changes to the solicitation documents:

**CLARIFICATIONS:** These directions shall have **precedence** over specification and drawings. Responsive bid shall provide all work and materials needed to provide a complete and operable project as clarified below:

- 1. No gas utility is required.
- 2. The following new equipment provided under this contract shall be painted as specified:
  - a. Generator, sub-fuel tank, and enclosure
  - b. ATS exterior enclosure
  - c. Meter socket exterior enclosure
  - d. All junction boxes on the equipment rack
  - e. Main Disconnect Switch, MDS-1
  - f. Lighting Panel exterior enclosure

The follow photo is an example of equipment rack and equipment from previous project that meets the intent of the contract and City standards.



3. The project does **NOT** require the existing LS-LCP-17 Lift Station Control Panel to be painted.

# 26 32 13.17 - LS17 Standby Engine Generator Set

Page 26 32 13-1, Paragraph 1.03(D)(2), line 30:

**REVISE** the word "natural" to read "diesel"

## 26 36 23.17 - LS17 Transfer Switch

Page 26 36 23.17-2, Paragraph 1.03(A)

Clarification: The supplied ATS with a Factory NEMA 1 enclosure. The ATS shall be installed within (inside) a separately supplied NEMA 3R/4X SS enclosure. (See example photo below.) Ensure ATS door opening is sufficient after installation within 2<sup>nd</sup> enclosure.

## <u>Lift Station Electrical Requirements:</u>

**REMOVE** The following text from **NOTE #10**:

"CONTRACTOR SHALL COORDINATE DIRECTLY WITH GAS UTILITY TO ARRANGE GAS SERVICE TO NEW GENERATOR."

**REMOVE NOTE #13** in its entirety:

"SPECIAL PAINT IS NOT REQUIRED AT THIS SITE."

CONDUIT & BOX SCHEDULE - Note 7:

**REPLACE** "LS No. 9 and LS No. 26" with "LS No. 17"
