- Bidders will need to be aware of scheduled Lakewalk events and will need to work around these dates
 - 9/16/23: Walk for Recover Lakewalk from Leif to Canal Pier
 - 9/23/23: Heart Walk Lakewalk from Leif to Canal Pier
 - 9/30/23: Grand Traverse Lakewalk from Endion to Fitger's
 - 10/6/23: GIS Consortium Fun Run Lakewalk from Endion to Fitger's
 - 11/11/23: Girls on the Run Lakewalk from Leif to Canal Pier
- Revetment should follow the natural contour of eroded bank.
- Barrier stones next to the outfall will need to be adjusted, marked and placed in the same order as they are right now.

Discussion Topics

- Construction Access
 - o Land access will require use of the carriage path
 - AMI will submit the previous specifications for the gravel material, in the first addendum
- Beach Clean Up
 - o The boundaries for the beach cleaning will be extended down to the revetment
 - Ocontractor must remove any blast rock, concrete, metal, geotextile fabric or misc. debris, 2 feet below grade, greater than 6-inches
 - Contractor must remove any non-native material greater than 6-inches discovered during the toe stone excavation
 - o Contractor shall, to the best of their ability, remove small pieces of metal found along the beach during the duration of the project.
 - o All stone removed from site becomes the responsibility of the contractor
- Due date for questions is the 22nd of August and answers are expected by August 24th
- All wood debris is to remain
- Contractor shall submit fencing layout for approval
- Contractor shall reinstall any of MnDOT's stones removed during the construction process
 - Stones must be placed back with three points of contact
