Scope of Work: This project consists of rehabilitation of the existing Brewery Creek Storm Sewer by means of lining. Lining may be accomplished by spirally winding and continuously welding a single strip of HDPE liner of the specified diameter into the RCP host pipe or by CIPP lining or by slip lining HDPE pipe of the specified diameter into the RCP host pipe. The project also includes traffic control, excavation, embankment and restoration of facilities and surfacing. The project includes 394 l.f. of 60" diameter lining.
