1. Introduction and sign-in sheet:

a. See Pre-bid sign in sheet.

2. General Project Overview:

- a. Leif Erikson Viking ship has lacked a permanent, protected location visible to the public.
 This iteration involves a wood framed, glass clad enclosure supported by concrete structural slab on deep foundations located at Superior St. & 10th Ave East.
- b. Geotechnical borings have been completed.
 - i. Question: Can the borings be made available to bidders? Yes, preliminary borings will be provided as part of Addenda #1. Schedule pending; see below.
- c. Electrical work involves removing and re-running wiring for relocated light pole. This is requested as a line item on the bid form.
- d. Multiple contractors involved, Johnson Wilson (or others) will provide layout and staking including cut-off elevations for helical anchors.
- e. Rough grading will be done by others, concrete bid package includes final grading as required for their work to be placed in compliance with the plans.
- f. Formliner patterns are specified in the drawings. Form sizing shall be coordinated to provide minimum clearance as noted in concrete specifications based on actual relief of selected formliner. Staining is a line item on the bid form.
- g. Site has limited access, and laydown areas. Damaged areas will be repaired to previous conditions at no cost. Parking, sidewalk and/or street closure permitting and coordination, for work completed by the concrete bidder, are the responsibility of the bidder.
- h. Site visit was not completed: meeting adjourned 2:31 pm.

Addenda # 1 will be released on or about Friday, March 4 at 11:00 am. All questions must be submitted by Thursday, March 3 at 3:00pm.

The preceding minutes are assumed to be a complete and correct account of the items discussed, directions given, and conclusions drawn, unless this office is notified of any modifications prior to the release of **Addenda #1**.
