

Addendum to Duluth Airport RFP # 17-4401


- 1. The RFP clearly states "janitorial and building maintenance" as reflected in tasks listed in Attachment #1. Is it your preference to have the Crew Leader be responsible for the various maintenance items in Attachment #1, or is it possible for maintenance, landscape and snow be subcontracted?
 - a. It is the preference of the Duluth Airport Authority that the Crew Leader be responsible for the various maintenance items in Attachment #1.
- 2. What is floor surface of restrooms?
 - a. Tile
- 3. Please confirm RFP response requires crew coverage 5:00 a.m. through 10:00 p.m. seven (7) days per week and Crew Leader only Monday through Friday.
 - a. The minimum coverage is based on flight schedule, the current target times are 5:00 a.m. through 10:00 p.m. Monday-Friday and 7:00 am through 7:00 pm Saturday-Sunday. The Crew Leader's typical shift is Monday through Friday and an alternate or fill-in for the weekend.
- 4. Please confirm equipment noted in Section IV.11 means any and all equipment not identified as Airport responsibility in Section V.2 is the full responsibility of contractor to provide.
 - a. Any and all equipment not identified as Airport responsibility in section V.2 is the full responsibility of the contractor to provide.
- 5. Is Non Standard Work as listed additional invoiced tasks?
 - a. Non Standard work will be conducted by the crew leader, if additional hours beyond the contract are required those hours would be invoiced.
- 6. Please identify current Airport approved floor finish system and if current system meets Airport Authority expectations.
 - a. Terra Glaze Acrylic Floor Seal
- 7. The RFP does not mention subcontracting. Is subcontracting allowed for janitorial work when closely managed by successful contractor?
 - a. Subcontracting is possible; specifically subcontractors can be used for project work. Beyond that subcontracting would need to be discussed during the contract phase.
- 8. Can a subcontractor be programmed into contract to perform specialized "Project Work" items?
 - a. See #7.
