**PROJECT DESCRIPTION:** Grass cutting (including push/ride mowing, edging and trimming) at various locations city-wide for the 2018 season (May through September). Two one-year renewal options. Locations are broken out by region; interested bidders can bid on one region or multiple regions. Bidders may be awarded more than one region. Please see the attached specifications and location listing for more information.

#### INSTRUCTIONS TO BIDDERS

By submitting a bid, Bidders are acknowledging that they have read the City of Duluth General Bid Specifications, which are included in this bid package.

Sealed bids must be received in Purchasing before 2:00 PM local time on the bid opening date specified above. DO NOT SUBMIT BIDS VIA E-MAIL; BIDS MUST BE IN A SEALED ENVELOPE. The City Purchasing Agent or her designee will conduct a public bid opening in Room 100 immediately following receipt of the bids.

No alternatives to the specification will be considered unless specifically requested.

The City of Duluth reserves the right to split the award where there is a substantial savings to the City, to waive informalities and to reject any and all bids.

#### The following documents must be submitted with your bid:

- 1. **Acknowledgment of Addendum –** any changes to this solicitation will be announced via Addendum. Bidders must indicate that they have reviewed any addendum(s) by initialing and dating on the bid form where indicated. Failure to acknowledge addendum(s) may result in your bid being deemed non-responsive.
- 2. **Affidavit of Non-Collusion** The successful bidder shall be required to execute the attached affidavit stating that he/she has not entered into a collusive agreement with any other person, firm, or corporation in regard to any bid submitted.
- 3. Affirmative Action/EEO The contractor must take affirmative action to ensure that the employees and applicants for employment are not discriminated against because of their race, color, creed, sex or national origin, and must meet the affirmative action goals. Contractors are encouraged to subcontract with Disadvantaged Business Enterprises (DBEs) when possible. Contractor will comply with all applicable Equal Employment Opportunity laws and regulations. Awarded contractor will submit the attached Equal Employment Opportunity (EEO) Affirmative Action Policy Statement & Compliance Certificate.

In addition, the awarded bidder must provide proof of Public Liability and Automobile Liability Insurance with limits not less than \$1,500,000 Single Limit prior to the commencement of work. The City of Duluth must be named as an additional insured.

#### **GENERAL BID SPECIFICATIONS**

- General. This document covers bids requested by the City of Duluth ("City"), including those requested on behalf of its Agents and Authorities. Each authority may issue their own purchase order or contract and will be responsible for it. The City of Duluth Authorities are as follows:
  - a. Duluth Airport Authority
  - b. Spirit Mountain Recreational Area Authority
  - c. Duluth Entertainment and Convention Center
  - d. Duluth Transit Authority
  - e. Duluth Economic Development Authority
  - Duluth Housing and Redevelopment Authority
- 2. <u>Investigation by Bidders.</u> Bidders are responsible for thoroughly reading and understanding the information, instructions, and specifications contained in this Invitation for Bids, and for investigating the site conditions at the Project location(s), if applicable. At the time of the opening of bids, each bidder will be presumed to have read and to be thoroughly familiar with the plans, specifications and contract documents (including all addenda). The failure or omission of any bidder to examine any form, instrument, or document shall in no way relieve the bidder from any obligation in respect to their bid.
- 3. <u>Bidder Questions.</u> Responses to general questions regarding the Invitation for Bids may be made at the discretion of the City. Every request for such interpretation should be in writing and delivered via e-mail or postal mail to the Purchasing Division before the deadline indicated on the Invitation for Bids, or if no deadline is specified, at least five (5) days prior to the scheduled bid opening. Responses will be issued in writing in the form of an Addenda or e-mail to prospective bidders.
- Changes, Corrections & Withdrawal of Bids. Erasures or other changes to the bid must be initialed and dated, however no special conditions shall be made or included on the bid form by the bidder.
  - Bidders may make requests to withdraw/replace their bids by notifying the Purchasing Division in writing prior to the bid opening.
- 5. <u>Unit Pricing.</u> If the total bid price is based on unit pricing, the City will verify the extended bid price for each item (obtained by multiplying the unit bid price by the bid item quantity). If any item is incorrectly calculated, the City will use the unit bid price to recalculate the extended item price and the total bid price.
- Sales Tax. The City has a sales tax exemption certificate, which will be provided upon request.
- Bid Submission. All bids must be complete, signed, and transmitted in a sealed envelope plainly marked with the bid number, subject matter, and opening date.
  - Bids may be mailed to the Purchasing Office, City Hall, 411 West 1st Street, Room 100, Duluth, MN 55802 or dropped off in person at the same address. Bids must be received by Purchasing before 2:00 PM local time on the date specified. Bids will not be accepted via e-mail unless specifically stated in the Invitation for Bids.
- 8. Non-Collusion Clause. By submitting a bid, the bidder, their agent and/or employee(s) hereby affirm that the attached bid or bids have been arrived at by the bidder independently and have been submitted without collusion with, and without agreement, understanding or planned common course of action with any other vendor of materials, supplies, equipment or services described in the Invitation for Bids, designed to limit independent bidding or competition
- 9. Award. Award, if made, will be to the responsible bidder submitting the lowest bid which complies with the conditions of the Invitation for Bids and specifications. A bid summary will be posted on the City website immediately following the bid opening. Awards for construction services and parts /supplies over \$100,000 must be approved by City Council.
- Bidder Qualifications. Per Sec 41.23(e) of Duluth City Code, price may not be the only consideration for award. The City will make such investigations as deemed necessary to determine the ability, capacity

and skill of the bidder to perform the work and perform it in the time specified without delay or interference, the reputation and experience of the bidder, the quality of the bidder's performance of previous contracts or services, and the sufficiency of the financial resources, equipment available and ability of the bidder to perform the contract. Bidders shall furnish to the City all such information and data for this purpose, when requested.

Minnesota law requires that, in order to transact business in the State, including submitting a response to this request for bids/proposals, a corporate entity of any kind must either be organized under Minnesota law or have a Certificate of Authority from the Minnesota Secretary of State to do business in Minnesota (M.S. 303.03) By submitting this bid/proposal as a corporation, you are certifying that the responding corporation complies with this requirement.

- Bid Opening. The City Purchasing Agent or her designee will conduct a public bid opening in Room 100 immediately following receipt of the bids. Results will be posted online at http://www.duluthmn.gov/purchasing/bids-request-for-proposals/ once all bids have been reviewed.
- 12. <u>Rejection of Bids.</u> The City of Duluth reserves the right to reject any and all bids and to waive any informalities or irregularities in bids received whenever such rejection or waiver is in its best interests.
  - The City reserves the right to reject any bid if the evidence obtained by the City through such investigation fails to satisfy the City that the bidder is properly qualified to carry out the obligations of the contract and to complete the work as required by the plans and specifications.
- 13. <u>Liquidated Damages for Failure to Enter into Contract.</u> The successful bidder, upon their failure or refusal to accept a purchase order or execute and deliver the contract, proof of insurance and bonds required within 10 days after receipt of a notice of the acceptance of their bid, shall forfeit to the City, as liquidated damages for such failure or refusal, the security deposited with their bid (if required).
- 14. Equal Employment Opportunity. Contractor will be required to comply with all applicable Equal Employment Opportunity (EEO) laws and regulations. Affirmative action must be taken to insure that the employees and applicants for employment are not discriminated against because of their race, color, creed, sex or national origin. The City of Duluth is an equal opportunity employer.
- 15. Quantities. The City reserves the right to increase or decrease the quantities of items within reason, unless otherwise noted.
- 16. Prevailing Wages. Per Sec 2-26 of Duluth City Code, payment of not less than the prevailing wage and salary rates specified in the contract documents and the conditions of employment with respect to certain categories and classifications of employees is required for all "Public Works" type projects estimated to exceed \$2,000. This does not apply to off-site production and manufacturing of parts and supplies.
- Validity of Bids: All bids must remain firm for 60 days from the date
  of bid opening, unless another period is noted in bid documents or if
  an extension is agreed upon, in writing prior to the end of the 60-day
  period.
- Insurance. All vendors doing work on City property, except vendors making routine deliveries, shall submit an insurance certificate verifying insurance coverage as per current city requirements.
- Reports. Contractors will be required to provide all data required by the city, state or federal funding source(s) for reporting purposes; including, but not limited to job creation and retention data, itemized invoices, payroll records, certifications and licenses.

It is the responsibility of each bidder to review the listed locations and familiarize themselves with the work necessary BEFORE submitting a bid. Failure to do so will not change the bid and the bids will remain firm.

Lots to be mowed are divided up into the following regions by location:

Region "1": East of 40th Ave E.

Region "2": Maple Grove Rd to Morgan Park Dr.

Region "3": 13th Ave W. to Hawthorne Rd (Including Park Point)

Region "4": 63rd Ave. W to 13th Ave W.

Region "5": West of 63rd Ave W

Each individual lot within a region is identified by a lot number and department for accounting purposes.

Parks (Park Maintenance)

PW & U (Public Works & Utilities)

M (Miscellaneous - Police, Library)

The reserves the right to add or remove lots within a region.

#### **Mowing Frequency**

The lot list indicates the estimated number of cuts required for each lot per mowing season. This is an estimate only, weather conditions may result in a lot requiring more or less cuts to maintain a neat and orderly appearance.

#### Bid & Award

Bids must include all costs to perform the services described, including all labor (walk and/or ride mowing, trimming and edging), materials, insurance, etc. Bids should be on a per location, per cut basis.

Some lots may require raking. Hourly rates will apply to raking and garbage pick-up when requested by the city.

The winning bid for each region will be calculated by multiplying the per cut cost for each location times the estimated frequency, and then adding all the lots in the region to get to a total estimated per region cost. More than one region may be awarded to the same bidder.

Award to be valid for 2018 mowing season (May-Sept), with two one-year renewal options.

#### Communication

The contractor MUST notify the appropriate location contact by phone or e-mail each day work is performed. City staff will verify and approve completed work. Failure to notify the location contact may result in delay or denial of payment.

#### **Invoices**

Invoices must be submitted at least monthly, and must be broken out by department with each location identified by lot number/description.

#### Insurance

The awarded contractor will be required to provide proof of insurance that meets the requirements shown below PRIOR to performing any work under this agreement.

- (1) Workers compensation insurance in accordance with applicable law.
- (2) Public Liability and Automobile Liability Insurance with limits not less than \$1,500,000 Single Limit and twice the limits provided when a claim arises out of the release or threatened release of a hazardous substance; and shall provide for the following: Liability for Premises, Operations, Completed Operations, Independent Contractors, and Contractual Liability.
- (3) City of Duluth shall be named as an Additional Insured under the Public Liability and Automobile Liability and Service Provider will provide Certificate of Insurance evidencing such coverage with 30-days' notice of cancellation, non-renewal or material change provisions included. The City of Duluth does not represent or guarantee that these types or limits of coverage are adequate to protect the Service Provider's interests and liabilities.
- (4) The use of an Accord form as a certificate of insurance shall be accompanied by two forms:
  - (i) ISO Additional Insured Endorsement (CG-2010 pre-2004) and
- (ii) Notice of Cancellation Endorsement (IL 7002) or equivalent, as approved by the Duluth City Attorney's Office.
- B. Such insurance shall protect Service Provider, its employees, agents and representatives from claims and damages including but not limited to personal injury and death and any act or failure to act by Service Provider, its employees, agents and representatives in the negligent performance of work covered by this Agreement.
- C. Certificates showing that Service Provider is carrying the above described insurance in the specified amounts shall be furnished to the City prior to the execution of this Agreement and a certificate showing continued maintenance of such insurance shall be on file with the City during the term of this Agreement.
