The City of Duluth, Minnesota requests sealed bids for the above named project. Bids may be submitted electronically through Bid Express® at [www.bidexpress.com](http://www.bidexpress.com) until 2:00 p.m. local time on Thursday, April 12, 2018. The City Purchasing Agent will conduct a public bid opening in City Hall, Room 100, immediately after the deadline for receiving bids.

**PROJECT DESCRIPTION & MAJOR WORK ITEMS:** Bituminous, concrete and brick pavement restoration and/or replacement needed due to prior city utility repairs. Work also includes reconstruction of approximately 200 linear feet of Burning Tree Road, new sidewalk construction at 19<sup>th</sup> Ave. East and Junction Ave., sidewalk replacement at 25<sup>th</sup> Ave. East, and sidewalk improvements for individual owners within city right-of-way at various locations throughout the city. We also have sidewalk quantities for work to remove and replace existing sidewalk with locations to be determined after bidding. These locations will be significant in length and generally a block long. Other work includes adjustment of existing electrical hand holes, minor repair of Bridges 1, 3, and 6 over Amity Creek, pedestrian hand rail repair and installation of new hand rail, and other pedestrian curb ramp work. Work also includes pavement jacking at 21<sup>st</sup> Avenue East.

Bidders will be required to create an Info Tech Digital ID in order to bid, which can take up to five (5) business days to process. Please allow ample time to obtain your digital id prior to the bid deadline. Bid Express® does charge a nominal fee for bid submission. Plans and specifications are on file for inspection at the City Engineering office, Duluth Builders Exchange, Minnesota Builder's Exchange, BXWI-Fox Valley Plan Room, and Blue Book Building and Construction Network.

Bidders must review the 2017 edition of the City of Duluth Public Works/Utilities Department – Engineering Division Standard Construction Specifications (available at <http://www.duluthmn.gov/engineering/standard-construction-specifications/>) as these Specifications are incorporated by reference.

Bid surety in an amount equal to five per cent (5%) of the total bid shall be submitted with each bid. Electronic bid surety can be submitted using Surety 2000 or InSure Vision Technologies, LLC. Paper bid surety must be mailed or dropped off in person at the purchasing office prior to the bid opening. Please clearly mark the envelope with the name of the bidder and the bid number.

Not less than prevailing wages as included in the specifications and provisions must be paid on this project. A Project Labor Agreement (PLA) will be required for any bid that is over or could virtually go over \$150,000.

The contractor must take affirmative action to ensure that the employees and applicants for employment are not discriminated against because of their race, color, creed, sex or national origin, and must meet the affirmative action goals. Contractors are encouraged to subcontract with Disadvantaged Business Enterprises when possible. Contractor will comply with all applicable Equal Employment Opportunity laws and regulations.
