Dear Friends:

The Parks and Recreation Annual Report provides us with an opportunity to update our partners, community members, visitors, and friends with a review of the Parks and Recreation projects and accomplishments throughout the last year and a brief look into the year ahead. Indeed, 2015 was an exciting year for Parks and Recreation in the City of Duluth.

On March 23, 2015, the City Council unanimously voted to approve moving forward with planning and visioning for the St. Louis River Corridor in front of a standing-room-only City Council chamber. The City Council preliminary approved both the projects and the corresponding ½ and ½ Tourism Tax expenditures. Since that date, the Parks and Recreation division, other City staff, and many partner organizations have worked diligently to begin work on the 28 projects that comprise the St. Louis River Corridor initiative. Many project-specific updates follow in this report. The total ½ and ½ Tourism Tax is \$18 million and will be spent over the next 4-5 years.

In 2015, we increased our focus on securing grants to fund our Parks projects. We received \$500,000 in federal and state grants for the Western Waterfront Trail, \$400,000 for the Duluth Traverse, and \$1,000,000 for Chambers Grove Park. All of these projects are moving from planning to implementation in 2016.

In our fourth year of administering the Parks Fund, we are again proud to report on the impact of those dollars. The Parks Fund provided resources for us to continue to address deferred maintenance and capital improvement projects across the City. In an effort to provide more interactive features and unique updates, we've updated the look and feel, as well as the layout, of our Annual Report. We added new sections, including 'What's New', 'Community', 'Parks Planning', and 'Glimpse Ahead'. Let us know what you think of the new layout.

Finally, we welcomed a number of new staff members in 2015, including Lisa Luokkala, Project Coordinator; Josh Abraham, Recreation Specialist; and myself, Lindsay Dean, Parks and Recreation Manager. In the Property and Facilities division, we welcomed Hank Martinsen, Property Services Manager; Danielle Erjavec, Property Services Specialist; and Alex Jackson, Energy Coordinator.

We have a talented, skilled and dedicated team that works hard to improve and maintain our park system every day. The Parks and Recreation team will continue to work diligently to support our mission and vision, working alongside the thousands of residents and visitors who enjoy our parks, trails, and recreation facilities year round.

CONSERVATION AND STEWARDSHIP OF OUR PUBLIC SPACES

With their overwhelming approval in 2011 of a referendum establishing a dedicated Parks Fund to enhance critical annual funding, the citizens of Duluth clearly recognized that the city's extensive public parks, gardens, recreation areas, and trail systems are vital to their quality of life and a vibrant economy

With an eye to the future, then Mayor Don Ness called on the entire community to join together in an ambitious and challenging endeavor to enhance the scope and quality of Duluth's public spaces for its citizens and future generations.

Mayor Ness, members of the City Council, Parks and Recreation Commission, Director of Public Administration, Jim Filby Williams, the Parks and Recreation Division under the leadership of Kathy Bergen, Parks Maintenance under Dale Sellner, Property and Facilities under Erik Birkeland, and many others in city government joined a diverse array of user groups, volunteers and citizens citywide to build remarkable momentum since the 2011 referendum.

Our citizens helped design a Duluth Parks and Recreation Master Plan, a Trails and Bikeways Master Plan, a Cross Country Ski Master Plan, numerous mini- master plans for parks and recreation areas from Brighton Beach, Hartley Park, Chester Bowl, Central Hillside, Wade Wheeler Western Sports Corridor, Memorial Park, Irving Park, Morgan Park, and Gary New Duluth to Chambers Grove, expanding Duluth's landmark Lakewalk, renovating Enger Tower and Wade Stadium, building new Duluth Traverse and Cross City trails systems and most recently, continued investment in the many St. Louis River Corridor Initiatives that support public park and trail improvements from Lincoln Park to the Fond du Lac neighborhood.

Many of these initiatives are described in the Annual Reports of the Parks and Recreation Division, which also includes the \$400,000 granted for 90 Neighborhood Parks Fund Grants to citizen led initiatives throughout the city since 2011.

Now in 2016, with the leadership of Mayor Emily Larson, a new City Council, and new Manager of the Parks and Recreation Commission Lindsay Dean, the opportunities to build on this significant momentum of the last five years are exciting and real.

Dynamic new plans for a revived Lake Superior Zoo, an enhanced Fairmont Park in West Duluth, and a restored Lincoln Park, are three important initiatives already approved by the Parks Commission and City Council in 2016.

As President of the Parks Commission, I continually stress the importance of enhancing resources to attack the extensive, and unacceptable, annual and accrued deferred maintenance needs throughout the city's parks system.

On September 9, 2015, the Parks Commission unanimously adopted a Resolution calling on the City of Duluth to "address annual and accrued deferred Parks Maintenance, together with needed related capital improvements, as high priorities in developing and approving the City's budgets for fiscal year 2016 and beyond."

I am pleased that last year Mayor Ness proposed, and the City Council approved, an increase in parks maintenance funding from the city's general budget for 2016, the first increase for parks maintenance since approval of the 2011 Parks Referendum.

This is an encouraging first step in addressing a critical issue. I urge the Mayor and the City Council to continue expanding resources to address the annual and accrued deferred parks maintenance needs in 2017, and in years beyond.

We are truly the beneficiaries of the foresight and commitment to open spaces that generations of civic leaders insisted be set aside and dedicated to public enjoyment and recreation.

However, if we fail to maintain what others have created, as well as all the exciting projects the City is now initiating, we will not be good stewards of our public places, and will regrettably pass on huge costs and problems to future generations.

Members of the Parks and Recreation Commission are strongly committed to the active conservation and maintenance of our public spaces.

We encourage attendance and public comments at commission meetings, so that all citizens and organizations are able to play an active role in determining the beneficial uses and assuring the conservation of Duluth's wonderful public parks, recreation areas, and trails.

Your continued support of Duluth's parks and trails does make a difference.







2015 EXPENDITURES \$2,664,761





WADE STADIUM

A \$4.6m renovation of the existing Wade Stadium, baselines and outfield walls (phase one) was funded with \$2.3m in bonding from the State of Minnesota and an equal match from the City of Duluth. The project provided a new drainage system, new lights, new scoreboard, new synthetic turf, and new fencing (including padding). Additional improvements include a concrete patio baseline viewing area; brick replacement, stabilization, and tuck-pointing of the stadium walls; a new concession area; and upgraded accessibility for patrons. The increased durability and drainage capabilities of the new artificial turf allowed the season to be extended two months and use of the field quadrupled. Additional phases of the renovation will continue as funding becomes available.

LESTER AMITY SKI TRAIL LIGHTING

In the fall of 2015 the City of Duluth Properties and Facilities Maintenance, on behalf of the Parks and Recreation Division, invested in a lighting upgrade for the Lester Amity Ski Trail. This upgrade replaced 95 - 250 watt high pressure sodium luminaires with 95 - 50 watt luminaires. This system upgrade offered several valuable benefits, including a dramatic reduction in electrical consumption, cost and pollution. The old system used approximately 34,580 kilowatts (kWh) annually. The new LED system uses only 6,920 kWh in a typical year, which is an 80% reduction in electrical use annually. Decreasing kilowatt usage by 27,664 kWh reduces CO₂ pollution by approximately 57,264 pounds annually. Additionally, the LED lights have a significantly longer life span which will reflect cost saving in annual maintenance expenses as well as on utility billings.

CHESTER CREEK CONCERT SERIES

We initiated a more objective process of choosing bands for Chester Creek Summer Concerts. A committee was formed, an application created and a deadline set. Over 30 musical acts applied to fill 10 available vacancies. The Committee, plus representatives from Chester Bowl Improvement Club, were given the applications, including web-links to sample applicants music. On selection day, the Committee met, discussed the objectives and voted. Preference was given to local talent. The results of the new selection process were heard throughout the summer, and feedback from the public was exceptionally positive.

ADOPTERS FOR EDIBLE DULUTH APPLE ORCHARDS

Edible Duluth, an initiative of Park Maintenance and the Volunteer Program, recruited seven local organizations to "adopt" a public fruit tree orchard in one of our parks. Each orchard featured approximately a dozen cherry and/or apple trees that bear fruit for public picking. Adopters helped water and monitor the trees for disease. Partners included The Izaak Walton League, Morgan Park Community Garden Club, Faith Lutheran Church, Northwood Children's Services, Duluth-Superior Eco-Rotary, the Kimball Family, Barr Engineering and Harbor City International School. MINNESOTA GREENCORPS

Parks and Recreation was the recipient of a Green-Corps member for the 2015-16 service year. Minnesota GreenCorps is environmentally fo-**AmeriCorps** cused program coordinated by the MPCA, which places Ameri-Corps members with organizations around the state to spend a year of service addressing critienvironmental cal issues, while gaining experience and learning valuable iob skills. Kevin Malmquist was selected as the Duluth Parks and Recreation member and has spent the first few months of his service year working on the Duluth Invaders service initiative and on Emerald Ash Borer education and management.





PORTLAND MALT SHOP STAIRS

In the spring of 2014 the stairs and bridge were taken out of service due to holes in the concrete on the landings. A structural analysis was completed and the recommendation was to replace the failing concrete treads and make repairs to the landings before returning the stairs to service. The project was completed in two phases. The first phase took place in 2014; temporarily repairing the holes in the landings, redesigning and replacing the concrete treads, allowing the stairs to be re-opened for the summer tourist season. The second phase was completed in the spring of 2015. In this phase the concrete treads and the concrete landings were removed. Structural steel was added, which enabled conversion of the landings to ipe wood (Brazilian walnut). The steel structure was painted, treads replaced, and ipe wood installed on the landings. Project challenges included working around the tourist season and over an active railway line. The end result brought the stairs up to current code and reset the life cycle on this access to the Lakewalk, one of Duluth's most popular attractions.

OBSERVATION DOG PARK

Observation Dog Park was an effort by volunteers who conceived, planned and performed much of the physical work that established Duluth's Second City Dog Park. The City of Duluth Park Maintenance team provided some material, equipment and a small amount of guidance to help complete the effort that was also supported by Community Parks and Recreation Program grants.

ADA RESTROOM FACILITIES AT CITY CENTER WEST

City Center West is home to the Branch Library and Evergreen Senior Center, both popular places that see а lot The bathrooms use. are shared that both of these groups did not meet accessibility standards as they were designed and built prior to those requirements. Today the public bathrooms meet accessibility guidelines by the Americans with Disabilities Act. In addition to meeting these standards, the newly remodbathrooms eled ceived a muchneeded interior finishes upgrade. As part of this project, a drinking fountain was relocated to an unused, obsolete phone alcove.





COBB SCHOOL PLAYGROUND

Late in the Fall of 2015 a new playground was installed to replace the existing playground that longer passed no inspection. safety Funded through Parks Fund En-Maintehanced nance, this beautiful new and exciting playground was designed for 5 to 12 year old children in neighborhood. Parents and Children can now walk to this site without having to cross Woodland Avenue to access playground.



Duluth Traverse Trail

The Duluth Traverse is a multi-use trail system linking neighborhoods and people to green spaces and the outdoors. It is a single-track, multi-use trail, purpose built for mountain bikes, stretching the entire ridge line of Duluth from Lester Park in the east to Chambers Grove Park in the west. It will be the first 100-mile trail system of its kind, wholly within an urban environment. At the end of 2015, 65 miles of the Traverse had been built.

In 2015, the City of Duluth built 7.1 miles of the Traverse in Mission Creek, connecting Chambers Grove Park to Becks Road. An additional 3.75 miles of the Traverse was completed between Lester Park and Hartley Park by City partner, Cyclists of Gitchee Gummi Shores (COGGS).

In 2016, the City will be bidding two contracts for construction of 17.4 miles of the Traverse connecting Spirit Mountain to Brewer Park, including the full build-out of the Mission Creek Trail Center. COGGS will be constructing an additional 4.75 miles in Hartley Park and Chester Park.

All proposed distances are subject to change pending results of the bidding phase.



CHESTER BOWL FUN SLOPE

The Chester Bowl Improvement Club, working with City of Duluth staff and private contractors, many of whom donated their time and materials, opened the new "Fun Slope" during the 2015 winter. newly skiable area was cleared and then peppered with berms and waves of man-made snow, creating a unique ski and snowboard experience that skiers and boarders of all ages loved! The City installed additional lighting to make this area safer at night. The Fun Slope has increased skiing capacity at Chester Bowl, which had a record number of users this win-Find learn more. ter. visit:




QUARRY PARK ACQUISITION

In 2015, as part of the larger St. Louis River Corridor Initiative, the City of Duluth pursued the acquisition of an abandoned rock quarry site to create a unique 30 acre neighborhood park with a world-class ice climbing facility. City of Duluth's Parks and Recreation Division worked interdepartmentally with Property Facilities Management to secure the property. A portion of the land was St. Louis County tax-forfeited land and the other portion was purchased from Oneota Cemetery Association. The acquisition process was completed in early 2016. The acquisition allowed the City of Duluth to protect informal greenspace adjacent to existing Parks which, in the future, will provide a neighborhood connection to regionally significant trails (Duluth Traverse Trail and Superior Hiking Trail). In addition, the re-use of a post-industrial site offers the adjacent neighborhood a formal green space to be used by the public long into the future.

Senior Programs

Due to the generous donations of two Duluth residents, Senior Programs was able to create a more modern, casino style bingo system at the Morgan Park and Portman Senior Centers. The remaining senior center, Evergreen, will transition to the new system in 2016.

The program increased in popularity as more youth programs were becoming interested in taking field trips to Bayfront Festival Park. Meanwhile the Community Art Kit program, which provides free art supplies, also increased in popularity among youth programs in Duluth.

Organizations struggled to transport participants and supplies to the needed locations, presenting a problem in taking full advantage of the programs. Through a partnership with True North AmeriCorps, two volunteers were assigned to distribute equipment and kits to youthserving agencies. Thus, many Duluth children were able to participate in the offered recreation programming. The volunteers maintained inventory of all supplies and worked with staff to help choose equipment based on age and interest of participants. Through the collective efforts of all involved, recreation grams saw an increase in participation in 2015.



SOCIAL INTERACTION

Learning how to have positive social interactions is a theme that runs through all of the youth programs. Program staff members realize that part of setting the youth up to succeed in the future has a lot to do with communication and social interaction with peers and adults. These skills are developed through contact with positive role models from college volunteers, agency members, staff and **AmeriCorps** representatives. Many youth were positively affected by this Parks and Recreation funding. Continuing this funding will ensure that Duluth's youth continued have access to opportunities and become empowered future leaders of our City.





Youth Programming

The youth organizations in Duluth continued programs that were originally expanded in 2012 with funding from the City of Duluth Parks and Recreation Division. The programs included providing educational and academic support, develop habits for healthy lifestyles, and learn how to have positive social interactions. The programs that received this funding included:

Boys & Girls Club (Lincoln Park)
Duluth Area YMCA True North AmeriCorps
Myers Wilkins Community School Collaborative (East Hillside)
Neighborhood Youth Services (Central Hillside)
Valley Youth Center (West Duluth and Gary New Duluth)

EXPANDED OPPORTUNITIES

The Parks and Recreation Funding continues to help the programs to reach a greater number of youth in our community. As a whole, these youth programs worked to reach 3,874 youth in 2015. This is over 1,000 more youth than were served by this funding in 2014.

The 25 True North AmeriCorps members served at several sites around the City including Mentor Duluth, YWCA Girl Power, Girls Scouts, Key Zone, Men as Peacemakers, Myers-Wilkins Community School Collaborative, Harbor Highlands Community Center, Downtown YMCA Youth Employment Program, City of Duluth Parks and Recreation, Valley Youth Center, and Neighborhood Youth Services. AmeriCorps members provided 26,660 tutoring hours to 1,398 students. This is a great example of collaboration as well as expansion of services to be sure that even more youth have access to a variety of enrichment programming. This was vital in sustaining the level of programming and support to kids in need in Duluth and adequately staffing the programs.

More youth are attending the programs more frequently than in the past. With the opening of the Steve O'Neill apartments, Neighborhood Youth Services had an increase in youth participants this year. The programs saw an increase in daily attendance as well as a significant increase in the number of meals served.

EDUCATIONAL AND ACADEMIC SUPPORT

A core focus of all of the youth programs is to see the youth they work with do well in school. Homework assistance and tutoring is a key part of each program. Students receive support, including 1-on-1 tutoring, peer support, and group tutoring sessions.

The summer programs are often a way to bridge the summer learning loss that occurs with a big break in traditional education. Opportunities offered by the different programs include environmental education, education based computer programs, reading programs, math and science. Other enrichment programs offered included life skills like; banking and saving, nature and science based learning, and safe computer usage. College and workplace readiness programs help to establish stepping stones for the futures of the youth.

All of the programs strive to provide positive adult role models for their participants. The Duluth Police Athletic League worked with programs to combine healthy activities with role modeling. Program staff empower youth to explore their interests and build self-confidence.

Myers Wilkins Community School Collaborative collects specific anecdotal responses from youth which show a good range of what their program is offering and what the youth are gaining from being involved:

- "I discovered I want to go to college."
- "I can do things I never knew I could do."
- "I can be confident in myself no matter what."

Many of these programs have great success rates, meaning the youth are indeed developing new skills. Not only are youth receiving education support but they are receiving the support of positive role models that strengthen them as an individual, and help them to gain positive life perspective.

HEALTHY LIFESTYLES

Each program integrates living healthy lifestyles into their programs. The programs work to integrate healthy nutritional snacks and meals into their program. But they go above and beyond simply offering food, several of the programs conduct cooking/ gardening activities so the youth begin to learn how to make healthy eating choices while at home. grams like Chef's Club and the JET Program help with the nutritional education and job skills. But there are countless other activities done by all the programs that promote healthy lifestyles. This includes learning to fish, outdoor survival programs, swimming lessons, and a variety of sporting and athletic opportunities get the youth active and in the habit of regularly getting outdoors and getting exercise.

The youth programs encourage tolerance and diversity by exploring different cultures. Some experiences youth participated in include Ojibwe drumming and beading classes, Indigenous Peoples Day, the UMD Kwanzaa Celebration, Hmong Culture Night, Latina Culture Night, and a visit from Ms. Malaak Shabaaz as part of Black History Month.




GOLF

PARKS STEWARDSHIP

In 2015 Parks and Recreation created a new focus within their division which is referred to as the Parks Stewardship Team. The focus of the team's work is around community engagement of the future use and development of public green space in Duluth, walking through every step of the process from public input meetings, planning, permitting design and construction. Uniquely, the Stewardship Team approach relies heavily on community partners to invest in parks infrastructure for the sustainability of existing and new amenities on public land.





CAMPUS CONNECTOR

The concept of a trail connecting the existing Lakewalk to eight elementary, middle, high school and college campuses was officially named through a naming contest during 2015. Campus Connector will serve as the first vertical trail connection in Duluth. It will connect the Lakewalk, via Congdon Park to the University of Minnesota Duluth's campus, on College Street to the College of St. Scholastica and to Rice Lake Road. In addition, Rice Lake Road will be improved in 2016 with a new, wide trail for bicycles and pedestrians from Mesaba Avenue to Arrowhead Road. Additionally, construction of an off street protected bicycle path on College Street from Junction Avenue to Kenwood Avenue will begin in 2016.

HARTLEY PARK LEGACY GRANT -PROJECT IMPLEMENTATION-

During 2015, Hartley Park underwent an Environmental Assessment Worksheet (EAW) process that examined all aspects of the proposed projects in Phase One implementation of the 2014 Mini-Master Plan. This included pine plantation thinning, parking lot expansion, hiking and biking trail improvements, Old Hartley Road improvements, accessible trail restorations, and removal of buckthorn and other invasive species. The Planning Commission was satisfied with the outcome, and permission was given to move forward. In 2016 the City will implement all of the projects related to the \$600,00 Legacy Grant.

MASTER PLANNING OUR PARKS

Since 2008 the Parks and Recreation Division began the process of creating master plan documents for many of the parks, trails and recreation facilities within the City of Duluth. The process of creating master plans takes time but the Parks Division is committed to developing these important guiding documents.

Master Plans:

- Provide an inclusive public process to determine the future uses of a park
- Engage stakeholders to understand park usage patterns and needs
- Complete an inventory of existing park amenities and infrastructure
- Create a clear "road map" of how to move forward with changes to the park



FEMA 2012 FLOOD PROJECTS

Work commenced in 2015 in several areas: Old Thomp-Road Hill above the Zoo was restored, as well as portions of western snowmobile trails and the old DWP rail bed. The hiking trail in Mission Creek leading up from the trailhead at 131st Avenue West was restored and once again connects to the Superior Hiking Trail. Planning documents were completed for repairs in Chester, Hartley and Congdon Parks, and work will commence there in 2016. Work will also be done Chester along Creek, which was heavily damaged.




ST. LOUIS RIVER CORRIDOR INITIATIVE -Connecting People to the River-



The St. Louis River Corridor Initiative invests in public park and trail improvements from Lincoln Park to the Fond du Lac neighborhood. The overall goals of the Initiative are to support the natural environment, enrich neighborhood quality of life, attract new home buyers, establish new visitor destinations and stimulate appropriate development. Initiative projects are funded in part by \$18 million in bonds, collected through the ½ and ½ tourism tax approved by the Minnesota Legislature in 2014. These funds will leverage additional dollars through community partnerships and grants.

28 projects make up the St. Louis River Corridor Initiative. Over a year into the Initiative, we are seeing projects move from concepts to formal planning processes, along with a select few moving into construction. Success can be seen in the implementation of Phase One plans for Gary New Duluth Recreation Area, Spirit Mountain Water System, Wade Stadium and Chambers Grove Shoreline Restoration, to name a few. In addition, the twenty mini master plans completed or initiated in 2015 are all related to the River Corridor projects. Anticipate seeing more visible progress on 28 projects in the upcoming year!

NEW SKI TRAIL GROOMER

In the fall of 2015 Park Maintenance purchased a new John Deere UTV tracked vehicle to add to our ski trail grooming fleet (PistenBulley 100 snow groomer and Arctic Cat Bearcat Snowmobile). The addition of the new UTV allows us to support the skiing community's request of increased grooming frequency. Our funds were limited to the purchase of the UTV only. DXC (Duluth Cross Country Ski Club) purchased and generously donated a new pull-behind groomer for the UTV, providing yet another example of collaboration and dedicated partnership to improve our parks and trails.

WESTERN WATERFRONT INVASIVE REMOVAL/RESTORATION/RENEWAL

After 30 years of deferred maintenance, the Western Waterfront Trail is set to receive a facelift, restoring it to its original condition. Invasive plant removal and habitat restoration is currently underway and will continue throughout the 2016 season from Blackmer Park in the west to 63rd Ave in the east. In the fall of 2016, the City will be restoring 3.3 miles of the trail, returning it to its original 8-foot wide surface and providing improvements to increase accessibility. Duluth Parks will also be completing a Mini-Master Plan for the Western Waterfront Trail in 2016 which will be inclusive of future extensions and future alignments.

RECREATION MANAGEMENT SYSTEM

In 2016, Parks and Recreation will be implementing a new recreation management software. The software will allow the public to register for programs and reserve park facilities online. The public will also be able to view schedules of park facilities and select desired reservation times, which will be reviewed and approved by parks and recreation staff. The launch of the recreation management software gives Parks and Recreation the capability of mass communication through emails, texts, and social media. Additionally, the software enables fee payments via credit cards online.

ASSET MANAGEMENT SYSTEM

For the past two years Property and Facilities Management (PFM) has been entering all of the City owned facilities' building systems, data, architectural drawings, and utility information into the City asset management system. The management asset system is used benchmark a facility by tracking building system lifecycles, and in so doing it directly supports capital planning and facility indecisionvestment making by providing capital improvement cost analysis and facility condition data for each building in the system. In 2016, PFM will be putting all of the Parks buildings into the City asset management system, and once that data is entered into the system, PFM will lead the development of a strategic facility plan for Parks facilities in 2017.

CHAMBERS GROVE PARK IMPROVEMENTS



Chambers Grove Park, damaged by the flood of 2012, will receive some much-needed attention in 2016. Currently under design, the improvements to the park will include replacing and relocating the bathroom facilities, new and expanded parking, a playground, St. Louis River access, and improved drainage and stormwater management. In recent years this beloved park has experienced significantly more use, in large part due to the new multi-use Mission Creek Trail system built by COGGS and the City of Duluth. This project is funded by a \$1 million DNR Legacy Grant for flood recovery.

LAKE SUPERIOR ZOO/FAIRMOUNT PARK



The City of Duluth and the Lake Superior Zoological Society worked collaboratively to create a concept plan for the Lake Superior Zoo and Fairmount Park. The planning team included City staff, Zoo staff, Zoological Society board members, and Parks & Recreation Commissioners. The planning process included input from citizens through four public presentations, as well as online and paper comments. The concept plan was unanimously approved by the Parks & Recreation Commission on March 9, 2016 and by the City Council on March 14, 2016. The Concept Plan features a revitalized, more compact 10-acre zoo for \$15.7 million and a signature park for the St. Louis River Corridor.
