

Notice of Public Comment Period and Public Hearing on the City of Duluth 2026 Action Plan AND FUNDING RECOMMENDATIONS for Housing and Community Development

*** Federal Funding Recommendations Included ***

The City of Duluth is seeking citizen comments on the 2026 Draft Action Plan and Funding Recommendations for Housing and Community Development. All input is welcome including identification of current community issues, especially those affecting people with low and moderate incomes. Comments about the City's progress toward five-year community development goals are outlined in the Plan. These funding recommendations are for approximately \$3 million from the U.S. Department of Housing and Urban Development. The Community Development Committee (CD Committee) plans and advises on the use of these funds to the Duluth City Council.

Contingency Plan: If there should be a higher level of funding allocated to the city for FY 2026 than estimated, such funding shall be distributed proportionally using the scores as a guide to previously recommended projects that were not recommended to receive full funding, up to 3% of the final allocation, and if less funding is allocated, all projects shall be reduced proportionally rounded to the nearest \$1000 dollar up to 3% of the final allocation. If the final allocated amount varies by more than 3% of the estimated amount then the Community Development Committee shall reconvene and revise the funding recommendation and submit it to the City Council.

There is a 30-day public comment period for the 2026 Annual Action Plan and funding recommendations from November 15, 2025 – December 16, 2025.

A public hearing on the recommendations will be held by the CD Committee during this time period at 5:30 p.m. on Tuesday, November 18, 2025, in Room 430, Lakeview Room – 4th Floor - City Hall. The purpose of the public hearing is for citizens to comment on the Draft Plan and the funding recommendations.

Members of the public, especially persons having low and moderate incomes, are encouraged to attend and provide comments.
