Sealed bids will be received by the City Purchasing Agent in and for the Corporation of the City of Duluth, Minnesota, at his office, Room 100 City Hall, Duluth, Minnesota, 55802, (218) 730-5340 until 2:00 local time on May 12, 2011 for the above named project. Immediately thereafter, bids will be taken to room 106A, City Hall, where they will be publicly opened and read aloud.

## NOTICE TO BIDDERS:

- 1. A Project Labor Agreement (PLA) will be required for any bid that is over or could virtually go over \$150,000.**
- 2. Unless a Certificate of Exemption is provided, any out-of-state bidder receiving a bid award will have 8% retained from invoice payments.**

The 2011 Street Preservation Project at 4<sup>th</sup> Avenue W., Arrowhead Road, 88<sup>th</sup> Avenue W., East 1<sup>st</sup> Street, Swan Lake Road and Skyline Drive. Project includes, but not limited to reclamation, milling existing bituminous, bituminous surfacing, storm sewer, striping and pedestrian ramps.

Each bidder must review the 2011 edition of the City of Duluth Public Works/Utilities Department – Engineering Division Standard Construction Specifications on the city website ([www.duluthmn.gov](http://www.duluthmn.gov)) as these Specifications are incorporated by reference and deemed to be a part hereof this project as if fully incorporated and set forth herein.

Plans and specifications may be secured from the City Engineering office, Room 211 City Hall, 411 West 1<sup>st</sup> St., Duluth, MN 55802, upon payment of a check, draft or money order in the amount of \$50.00 made payable to the City of Duluth. (This payment will not be refunded.) No plans will be issued without stipulated payment.

Plans and specifications are on file for inspection at the City Engineering office, Duluth Builders Exchange, McGraw-Hill Construction ([www.dodge.construction.com](http://www.dodge.construction.com)), Minneapolis Builders Exchange and St. Paul Builders Exchange.

A certified check or bank draft, payable to the order of the City of Duluth, negotiable U.S. Government Bonds (at par value), or a satisfactory bid bond executed by the bidder and acceptable surety, in an amount equal to five per cent (5%) of the total bid, shall be submitted with each bid.

Attention is called to the fact that not less than the minimum salaries and prevailing wages as set forth in the contract documents must be paid on this project. The contractor must take affirmative action to ensure that the employees and applicants for employment are not discriminated against because of their race, color, creed, sex or national origin, and must meet the affirmative action goals. Contractors are encouraged to subcontract with Disadvantaged Business Enterprises when possible.
