### City of Duluth - Western Waterfront Trail & Park Master

Online Survey Response Data

Preliminary Survey Data Interpretation March 6, 2017 Prepared by LHB, Inc.

#### **Purpose**

The purpose of the survey was to gather a broader data set on preferences regarding the future development of the Western Waterfront Trail. It was important to include an online survey in the methodology of community engagement to offer an alternative method to engage with stakeholders on the project beyond the community meeting. The survey was necessary in order to reach a broader audience beyond our community engagement meeting format.

#### Method

The City working with LHB developed an online survey to gather feedback on preferences for the Western Waterfront Trail. The survey was live from January 9th-January 26<sup>th</sup>. It featured 29 questions. With a total of 988 responses. The survey was advertised on the City's website and received some media attention through television<sup>1</sup> and newspaper<sup>2</sup>.

#### Objective

The purpose of the survey was to invite participation and define priorities for the Western Waterfront Trail. Key objectives included, determine existing use and activity type along the corridor. Identify the current rail experience values. Distinguish unique and culturally significant features to celebrate, determine priority site improvements preferred at each access point.

#### **Participants**

Of the 988 respondents over 80% identified as Caucasian with nearly 14% selecting "I prefer not to respond." Nearly 54% of respondents identified as male with less then 40% respondents identifying as female. The highest percentage of respondents at nearly 35% were age 60 or older followed by almost 40% between the ages of 40-59.



More than 50% of respondents characterized their use of the existing WWFT was limited to once a month to once a year.


### Q1 How often do you use the existing Western Waterfront Trail?


### Q2 How often do you use the existing Lake Superior & Mississippi Railroad excursion train?


# Q3 How often do you use one of the existing river public access points (Munger Landing, Boy Scout Landing, Perch Lake Access)?

## Q4 Which activities do you do most often on the existing 3.3 mile Western Waterfront Trail corridor? (choose up to 3)






### **TOPIC AREA – VALUES**







Public Access to river shoreline; Historic and natural resource implementation and Signage and Wayfinding ranked highest as priority trail elements.


### Q10 Which trail elements will be a priority in the next 5 years? (Please rank)


## Q11 Which park elements, adjacent to the trail, will be a priority in the next five years? (Please rank)

## Q12 What park and trail improvements would add most value to the rail experience?





# Q14 For the Munger Landing preliminary site plan below, what should the top two site improvements be? (please rank)



# Q15 For the Boy Scout Landing preliminary site plan below, what should the top two site improvements be? (please rank)



# Q16 For the Perch Lake River Access preliminary site plan below, what should the top two site improvements be? (please rank)



Kayak and canoe put-in site ranked highest for Slag Point landing site improvements closely followed by historic and natural resource interpretation and restore shoreline with shore fishing.


# Q17 For the Slag Point River Access & Greenspace preliminary site plan below, what should the top two site improvements be? (please rank)






### Q22 How long have you lived in the Duluth area?


### Q23 Do you work in the Duluth area?


### Q24 Which category below includes your age?


### Q25 How many children (0-12 years old), teenagers (13-17 years old), adults (18-64 years old), and seniors (65+ years old) live in your household?
