**ADD** the following subsection to section SP-10 of the special provisions.

**F.** The contractor will designate one individual employee who will be responsible for picking up and delivering parts from the City of Duluth's warehouse to the job site(s).

**REPLACE** the following sentence to subsection F of section SP-18 Measurement and Payment.

- **F.** "Payment for Reconnecting an Existing PE service to a New Main." With
- F. "Payment for Reconnecting an Existing PE service to a New Main or Existing Service."

**ADD** the following subsections to section SP-18 Measurement and Payment

EE. Payment for **Furnish & Install ½" Riser & Meter Stop** shall be paid for at the unit price bid per each and shall be compensation in full for all costs to excavate, furnish and install a new ½" riser, meter stop and necessary fittings, testing, backfilling and turf establishment.

- FF. Payment for **Furnish & Install 1" Riser & Stop Valve** shall be paid for at the unit price bid per Each and shall be compensation in full for all costs to excavate, furnish and install a new 1" riser, meter stop and necessary fittings, testing, backfilling and turf establishment.
- GG. Payment for **Furnish & Install 2" Riser & Stop Valve** shall be paid for at the unit price bid per Each and shall be compensation in full for all costs to excavate, furnish and install a new 2" riser, meter stop and necessary fittings, testing, backfilling and turf establishment.
- HH. Payment for the **Remove Risers** bid item shall be paid for at the unit price bid per each and shall be compensation in full for all costs associated with excavation, removal and disposal of an existing riser, abandonment of any service piping left in the ground with a PE cap or other abandonment measure, backfilling, and turf or vegetative restoration as necessary. Item will not be paid for when new riser is placed in existing location.

ADD the following special provision SP-25 Gas Services.

**SP-25 Gas Services**. Gas service plans will be issued in packages based on application dates. The contractor shall dedicate 1 working week each month to installing gas services. The contractor shall install said services within 60 calendar days of being issued via dropbox.
