## INVITATION TO BID HOT WATER PACKAGED ENERGY TRANSFER STATIONS PHASE 3

**PROJECT DESCRIPTION:** Duluth Energy Systems (DES) in Duluth, MN, is undergoing a conversion from a steam-based district energy distribution network to a hot water-based district energy network. The current once-through steam distribution network under Superior Street in downtown is being replaced with supply and return hot water piping. Interested bidders are invited to submit a bid to provide packaged hot water energy transfer stations (ETS) for buildings included in Phase 3 of the project. Please see the Scope of Work and attachments for more information.

Bids may be submitted electronically through Bid Express® at www.bidexpress.com until the bid opening. Electronic bids are preferred; suppliers wishing to submit a paper bid must contact the purchasing office. **E-MAIL BIDS WILL NOT BE ACCEPTED.** The City Purchasing Agent will conduct a public bid opening in City Hall, Room 120, immediately after the deadline for receiving bids.

No alternatives to the specification will be considered unless specifically requested. Erasures or other changes to the bid must be initialed and dated, however no special conditions shall be made or included in the bid form by the bidder.

The City of Duluth reserves the right to split the award where there is a substantial savings to the City, to waive informalities and to reject any and all bids. Price may not be the only consideration for bid award. Bids must be firm for a minimum of 60 days.
