

# Business Loan and Grant Programs

#### St. Louis County Small Business COVID Relief Grants

St. Louis County Small Business COVID-19 Relief Grant applications available starting at **9:00am on January 19, 2021**. These grants are available to both eligible businesses and non-profits that are physically located in St. Louis County.

#### MN Department of Revenue - State COVID Business Assistance

Direct payments from the Department of Revenue for eligible businesses (Restaurants, Cafeterias, Buffets, Caterers, Bars, Breweries, Winerys, Tap Rooms, Bowling, Fitness Centers, Gyms). Requirements are: 1) located in MN; 2) at least \$10,000 in sales in 2019; 3) Must have filed tax returns in 2019 and 2020; 4) must show required loss of revenue (see below); 5) must have been forced to close due to Executive Order. Sales Tax revenue will be used to show loss (req. loss of 30% between April and Sept 2020 to be eligible) and current unemployment records will be used to determine payment amount based on number of employees. **Businesses will be notified by 12/31/20 via their e-services accounts** and funds will be mailed in early January 2021 to the main sales tax account address on file. ## SBA - Economic Injury Disaster Loan (EIDL)

Low-interest federal disaster loans for working capital to small businesses suffering substantial economic injury as a result of Coronavirus (COVID-19). This program is for small businesses and most non-profit organizations that have suffered directly by this disaster. Loans can be for up to \$2 million and may be used to pay fixed debts, payroll, accounts payable, and other bills that could have been paid had the disaster not occurred. Loans under \$25,000 can be made without collateral, loans over \$25,000 should be collateralized. Loans are paid back over 30 years at 3.75%, and payments are deferred for one year. However, the SBA will not decline a loan for lack of collateral.

#### DEED – Business Loan Guarantee Program

The Northland Foundation is the local lender with this program. Loan funds can be used for machinery or equipment purchases, maintenance, or repair and working capital when secured by fixed assets. Terms are flexible and the State of MN provides an 80% guarantee up to \$200,000. #### IRRRB – Taconite Area Business Relief Loan Program

For businesses in Virginia and the Iron Range. Maximum loan amount to a business equal to three months operating expenses, up to \$40,000. Maximum loans will be 60 months, after a six-month deferment period. Two percent interest rate, accrued interest will be due at the end of the deferment period. Administered by the Entrepreneur Fund. # Services for Incumbent and Laid-Off Workers

## **Duluth Workforce Development Dislocated Worker Program**

Our Dislocated Worker program offers free services to help individuals who have been laid off, either permanently or temporarily, find suitable employment and help take the stress and uncertainty out of the process. Workers may be eligible for this program if they are out of work through no fault of their own, are eligible for unemployment insurance, and are unlikely to return to your previous occupation or industry. <u>https://duluthmn.gov/workforce-development/dislocated-workers/</u>

#### Talent Development Program

Duluth Workforce Development's Talent Development Program offers direct financial assistance to train incumbent workers and improve economic competitiveness of regional businesses. TDP provides matching grants to support direct training costs for current employees. ## Pandemic Unemployment Insurance for Self-Employed Individuals

Self-employed individuals, contract workers, and others identified in the federal CARES Act are now eligible to apply for Unemployment Insurance in Minnesota. ### **DEED – Unemployment Insurance Information for Employers**

On March 16, Governor Walz issued an executive order ensuring workers affected by COVID-19 have full access to unemployment benefits. The order also relieves taxpaying employers of benefit charges associated with COVID-19. This means a company's unemployment tax rate will not increase if your workers collect unemployment benefits due to COVID-19. If your workers apply for unemployment benefits, DEED will let you know. ## **DEED – Shared Work – Alternative to Layoffs**

Employers experiencing a slowdown in their businesses or services as a result of the coronavirus impact on the economy may apply for the Unemployment Insurance Shared Work Program. This program allows employers to seek an alternative to layoffs - retaining their trained employees by reducing their hours and wages that can be partially offset with UI benefits. Workers of employers who are approved to participate in the Shared Work Program receive the percentage of their weekly UI benefit amount based on the percentage of hours and wages reduced, not to exceed 60 percent.  Anytime a Minnesotan loses health coverage, including employer-sponsored coverage, they are eligible to enroll in coverage through MNsure via a special enrollment period for the 60 days following the loss of coverage. (Details <u>here</u>.) Additionally, if someone is eligible for Medical Assistance or MinnesotaCare, enrollment is available at all times, regardless of when they might have last had coverage.
