OUTFALL REPAIRS ON CONGDON BLVD

BID NUMBER: 20-99426

BID OPENING: Wednesday, July 1, 2020 at 2:00 pm

PROJECT DESCRIPTION: Stormwall and bin outfall repairs, including shoreline rehabilitation. Work scopes includes cast-in-place concrete, stone placement, structural steel, site clearing, earth moving, and erosion and sediment control.

PRE-BID MEETING: A pre-bid meeting will be held at on Tuesday, June 16, 2020 at 12:00 noon. Interested bidders are encouraged to attend, and should meet in the parking area at approximately 7428 Congdon Boulevard, Duluth, MN.

QUESTIONS: Please submit any questions regarding this project via e-mail to <u>purchasing@duluthmn.gov</u>. **Deadline for questions is Wednesday, June 24, 2020**. Responses will be issued as an addendum to this solicitation.

PROJECT SCHEDULE: Contractors will be required to start as soon as notice to proceed is issued. Depending on the contract amount(s) awarded and whether council approval is required, that date may vary, but is anticipated between July 9 and July 16. All in water work must be completed by September 15, 2020. Substantial completion date is October 15, 2020.

The selected contractor will be issued a construction contract (draft included in the Standard City Contracting Forms in the BidExpress solicitation). Notice to Proceed will be issued once the agreement is fully executed.

Specifications may be viewed and downloaded at no cost at <u>www.bidexpress.com</u>. Bidders must create a free account with Bid Express®; and login to search for city projects (search by "City of Duluth" or bid number). Bid Express® does charge a nominal fee for bid submission. Proposal forms, contract documents, plans and specifications may also be on file at the following offices: Minnesota Builder's Exchange, Builder's Exchange of Wisconsin, and Blue Book Building and Construction Network.

INSTRUCTIONS TO BIDDERS

Due to the closure of City Hall due to the COVID-19 pandemic, all bids must be submitted electronically through Bid Express® at <u>www.bidexpress.com</u>. Bid bonds must also be submitted electronically – either thru Surety2000 or SurePath in the BidExpress solicitation, or emailed to <u>purchasing@duluthmn.gov</u> prior to the bid opening. If submitting a certified check or bank draft, bidder must contact Purchasing seven days prior to bid opening to make arrangements.

The City Purchasing Agent or her designee will conduct a public bid opening immediately after the deadline for receiving bids. Bidders may view the opening by selecting the appropriate link on the Purchasing web page (<u>https://www.duluthmn.gov/bids-request-for-proposals/</u>).

A certified check or bank draft, payable to the order of the City of Duluth, or a satisfactory bid bond executed by the bidder and acceptable surety, in an amount equal to five per cent (5%) of the total bid must be

submitted by the bid deadline. Electronic surety may be submitted through Bid Express; copies of paper bid bonds may be emailed to <u>purchasing@duluthmn.gov</u>, but must be sent and received prior to the bid opening date and time. Bids may be withdrawn without forfeiture of surety if the request is submitted by the Bidder and received at the Purchasing Office in writing or by e-mail prior to the scheduled bid opening.

No alternatives to the specification will be considered unless specifically requested. Erasures or other changes to the bid must be initialed and dated, however no special conditions shall be made or included in the bid form by the bidder.

The City of Duluth reserves the right to split the award where there is a substantial savings to the City, to waive informalities and to reject any and all bids. Price may not be the only consideration for bid award. Bids must be firm for a minimum of 90 days.

Please note that the following requirements also apply to this project, and any additional required documents must be submitted prior to award/contract execution.

1. **Insurance** – Contractor must provide proof of Public Liability and Automobile Liability Insurance with limits not less than \$1,500,000 Single Limit prior to the commencement of work. The City of Duluth must be named as an additional insured. Please refer to the draft Contract, Section 7.

2. **Performance & Payment Bonds** – The awarded contractor will be required to submit performance and payments bonds in the full amount of the project cost prior to award.

3. **Out of State Contractor** - Unless a State of Minnesota Certificate of Exemption is provided, any outof-state bidder receiving a bid award will have 8% retained from invoice payments on any contracts over \$50,000. 4. **Prevailing Wage** - Not less than the minimum salaries and prevailing wages as set forth in the contract documents must be paid on this project.
