
## **The City Hall Grounds Improvement Project**

### **Important updates on Building Entrances, parking and accessibility routes:**

- **Effective 5/12** – Parking Services has designated 3 additional temporary ADA handicap parking spots near the Federal building in Priley Circle. These will be in place for 6-8 weeks. If parking in ADA parking spots on Priley Dr., please use the ramp located between the Federal building and St. Louis County Courthouse and follow the route straight to City Hall. See map for details. Wayfinding signage has been placed around City Hall and outside project zone directing folks to ADA parking as of Monday morning.
- **Effective 5/17** – We have created 3 TEMPORARY ADA parking stalls in the garage area next to the 4<sup>th</sup> Ave City Hall building entrance. These will be in place for the next 6-8 weeks until the 2<sup>nd</sup> Street parking lot is open. The 4<sup>th</sup> Ave Building Entrance will be open for employees and individuals in need of accessible parking. Please do not park in this area unless you have a handicap parking permit.
