**Approval of the May 5, 2021, Alcohol, Gambling & Tobacco Commission Minutes.** *Commissioner Rosenthal moved to approve the May 2021 minutes and was seconded by Commissioner Stolee. The motion passed unanimously.*

(DUBH LINN BREW PUB)** – APPLICATION FOR A PERMANENT EXPANSION OF THE DESIGNATED SERVING AREA ASSOCIATED WITH AN ON-SALE INTOXICATING LIQUOR LICENSE, 109 WEST SUPERIOR STREET, MIKE MAXIM PROPRIETOR *Commissioner Rosenthal moved to approve and was seconded by Commissioner Stolee. The motion passed unanimously.*
