Superior Street Reconstruction Update: Word on the Street (August 6, 2020)

Wrap-up of Last Week

- -Crews removed bricks, paving and ledge rock throughout the project zone.
- -Carpentry crews worked on the east plaza at Lake Ave.
- -Crews finished pouring concrete roadway at Lake Ave.
- -Pipefitters continued installing the hot water lines between Lake Avenue and 1st Avenue West.
- -Crews began preparing watermain to be placed into 2nd Avenue West.

What to Expect August 5 - 12

- -Access to businesses and residences will remain open.
- -Bricks, pavement and ledge rock will continue to be removed throughout the project zone.
- -Structural work on vaults and the east plaza at Lake Avenue will continue.
- -Signal steel will be installed in Lake Avenue.
- -Electrical duct will be run between 1st Avenue West and 2nd Avenue West.
- -Hot water installation will continue between Lake and 1st Avenue West.
- -The intersection at 3rd Avenue West and Superior Street will be closed beginning Monday, August 10 through the end of the construction season. Traffic on Michigan Street between 3rd Avenue West and 4th Avenue West will convert to two-way to accommodate bus traffic.
