Superior Street Reconstruction Update: Word on the Street (August 13, 2020)

Wrap-up of Last Week

- Crews removed bricks, paving and ledge rock throughout the project zone.
- Carpentry crews worked on the east plaza at Lake Avenue.
- Crews finished pouring concrete roadway at Lake Avenue.
- Pipefitters continued installing the hot water lines between Lake Avenue and 1st Avenue W.
- Crews placed the final lid of the storm sewer system within 1st Avenue West.
- Electrical duct was run from 1st Avenue West to 2nd Avenue West.
- Crews began preparing watermain to be placed into 2nd Avenue West.
- 3rd Avenue West was closed to vehicular traffic.

What to Expect August 12 - 19

- Access to businesses and residences will remain open.
- Bricks, pavement and ledge rock will continue to be removed throughout the project zone.
- Structural work on vaults and the east plaza at Lake Ave. will continue.
- The Lake Avenue intersection will be striped.
- Signal steel will be installed in Lake Avenue.
- Electrical duct will be run between 1st Avenue West and 2nd Avenue West.
- Hot water installation will continue between Lake and 1st Avenue West.
