#### PHASING

- PHASE 1 REMOVE/RELOCATE EXISTING UTILITIES (TELEPHONE, POWER, AND INTERNET), REMOVE/CAP EXISTING UTILITIES (SANITARY, WATER, AND GAS), AND REMOVE EXISTING SITE ELEMENTS (SIDEWALK, SUPPORT SLABS)
- PHASE 2 REMOVE ASBESTOS AND REGULATED WASTE MATERIALS IN HERMANTOWN HYDRAULICS STRUCTURE PHASE 3 - DEMOLISH HERMANTOWN HYDRAULICS STRUCTURE (INCLUDING FOUNDATION, FOOTINGS, AND
- SLABS).
- PHASE 4 SOIL REMEDIATION AND RESTORATION

SECURITY

- THE INTENT IS FOR THE CONTRACTOR TO REMAIN WITHIN THE SITE LIMITS. ORANGE CONSTRUCTION FENCE IS TO BE INSTALLED ALONG THE PERIMETER TO MARK BOUNDARIES AND KEEP WORKERS WITHIN LIMITS. CHAIN LINK SECURITY FENCE CAN BE SUBSTITUTED.

#### DEMOLITION

- PHASE 1 CONTRACTOR TO REMOVE ALL DEBRIS, EXISTING SITE UTILITIES (AND COORDINATE), DISCONNECTS, CONFLICTS AND OTHER RELATED ITEMS PRIOR TO
- PHASE 2 CONTRACTOR TO COMPLETE REMOVAL OF ASBESTOS AND REGULATED WASTE MATERIALS.

#### RESTORATION


#### ITEM NOTES:

THESE QUANTITIES ARE ESTIMATED FOR INSTALLATION & BIDDING PURPOSES. APPROPRIATE DOCUMENTATION NEEDS TO BE SUPPLIED TO THE ENGINEER FOR FULL PAYMENT.

#### ALTERNATE A IS SEPARATED OUT FOR FUNDING PURPOSES ONLY.

ITEM 1: THE TERM "GENERAL CONDITIONS" IS USED TO DESCRIBE EXPENSES THAT SUPPORT A PROJECT WITHOUT DIRECTLY RELATING TO JOBSITE ACTIVITIES, INCLUDING BUT NOT LIMITED TO SITE MANAGEMENT, PERMITTING, PROJECT MANAGEMENT, AND COORDINATION.

- ITEM 2: MOBILIZATION SHALL BE LIMITED TO 10 PERCENT OF THE TOTAL PROJECT COST.
- TO BE REPLACED, THAT COST IS CONSIDERED INCIDENTAL ITEM 5: INCLUDES THE MAINTENANCE, CLEAN UP, AND RESTORATION (IF NECESSARY) OF HAUL ROUTES. REPAIRS TO ANY DAMAGES MADE WILL BE THE RESPONSIBILITY OF THE
- CONTRACTOR
- ITEM 6: INCLUDES INSTALLATION, MAINTENANCE, AND REMOVAL OF ALL TRAFFIC CONTROL SIGNAGE, BARRICADES, TEMPORARY SECURITY FENCING, AND TRAFFIC CONTROL DEVICES
- ITEM 7: THIS IF FOR REMOVING ADDITIONAL UNSUITABLE SOILS FOR FUTURE BUILDING PROJECT. CONFIRM SUBSURFACE SOILS WITH QA FIRM TO REMOVE A REASONABLE AMOUNT OF MATERIAL. THIS ITEM IS NOT INTENDED TO REMOVE WITHIN THE WHOLE SITE. BUT JUST THE EXTENTS OF THE PREVIOUS BUILDING FOOTPRINT, AFTER SOIL REMEDIATION HAS BEEN COMPLETED.
- ITEM 8: ASSUMES BUILDING FOOTINGS AND FLOOR SLABS, AND AREA UNDERNEATH THE STRUCTURE FOOTPRINT WILL BE REMOVED AS WELL ITEM 9: REMOVING ITEMS THROUGHOUT THE WHOLE SITE, INCLUDING BUT NOT LIMITED TO, ASPHALT/CONCRETE PAVEMENT, SIDEWALK, MISCELLANEOUS STRUCTURES, SUPPORT SLABS, TREE, LANDSCAPING, MAILBOX, CULVERT, UTILITIES BELOW GRADE, ETC.
- ITEM 12: THIS IS FOR ALL DEWATERING EFFORTS REQUIRED ON THE PROJECT, INCLUDING INSTALLING, MAINTAINING, REMOVING, ANY PERMITTING, FEES OR OTHER RELATED COSTS TO PROVIDE A DEWATERING SYSTEM ON THE PROJECT AT ANY POINT. NO ADDITIONAL PAYMENT BEYOND WHAT HAS BEEN BID WILL BE CONSIDERED FOR THIS ITEM. ITEM 13: PLACEMENT OF SUITABLE BACKFILL MATERIAL FOR FUTURE BUILDING SITE. THIS MATERIAL SHALL BE IMPORTED, PLACED, AND COMPACTED IN THE VOIDS LEFT FROM THE COMPLETE BUILDING REMOVAL, SITE & UTILITY REMOVALS, AND SOIL REMEDIATION EFFORTS. CERTIFIED LOAD TICKETS MUST BE PROVIDED TO THE ENGINEER FOR PAYMENT. THE CALCULATED AMOUNT IS FOR COMPACTED VOLUME.
- ITEM 14: THIS INCLUDES GRADING, UNIFORM TURF ESTABLISHMENT (SEEDING, FERTILIZER, MULCH) AND ANY OTHER MEASURES REQUIRED TO RETURN THE AREA TO PRE-CONSTRUCTION CONDITIONS OR BETTER, AS APPROVED BY ENGINEER.
- THEM 15: SELECT TOPSOIL BORROW TO BE USED AS SUPPLEMENTAL TOPSOIL. CONTRACTOR SHALL USE SALVAGED ON-SITE TOPSOIL PRIOR TO ANY IMPORT OF SELECT TOPSOIL BORROW, OR AS DIRECTED BY ENGINEER. TOPSOIL TO BE PLACED AT 4-INCH THICKNESS THROUGHOUT THE SITE. ITEMS 7, 13, & 15: ASSUMED A SOIL UNIT WEIGHT OF 125 PCF TO DETERMINE QUANTITIES IN TONS IN ORDER TO MATCH LOAD TICKETS.
- ITEM 16: THERE IS AN ESTIMATED 10-FOOT BUFFER AROUND THE AFFECTED AREA IN ORDER TO ALLOW REMEDIATION TO HAVE ITS MAXIMUM EFFECT AND EFFICIENCY. VERIFY WITH ENGINEER FOR EXTENT OF REMOVALS.




