#### **Summary of Economic Development Applications**

Seven applications were received for the CDBG Economic Development category. The applications include programs designed to help start and grown small businesses and programs that provides services including case management, work readiness training, and job placement and retention support to low- to moderate-income Duluth residents. The CD Committee set a funding target of 20% for CDBG Economic Development funding in FY 2025, which would be \$470,499 using the FY 2024 allocation.

#### **Approach to Application Review**

Applications were reviewed for funding eligibility, consistency with the Consolidated Plan Goals, Imagine Duluth 2035 Comprehensive Plan, and goals and outcomes set by the Duluth Workforce Development Board. These proposals were reviewed based on the need for the proposed projects, benefits to the community, budget, and project readiness.

- FFC partners with YES Duluth to host paid work experience for a few youth assisting with their after school program which includes some career counseling and access to further training for those participants
- The work they are doing through START would not be considered job training or career development, as it is not connected to specific skills needed for high-demand occupations, is not informed through employer engagement or partnership, and does not lead to industryrecognized credentials. It also does not include job placement assistance or assistance overcoming barriers to employment. Instead, this would be considered hands-on career exploration.
- START program model could be significantly strengthened, including a competency-based training model leading to industry-recognized credentials, and a stronger partnership with Workforce Development to connect participants to further credentialed training, career counseling, support in overcoming barriers to employment, paid work experience, and connection to employment.

- How does START create pathways to business ownership? Entrepreneurship component needs additional detail to clarify project design and implementation plan including how it connects to other programs (including those funded by CDBG) to support business creation/expansion.
- Macro goal is participation in two workshops, which is not sufficient for skill development and does not lead to industry-recognized credential. As such, this would be classified as work readiness and/or career exploration
- Meso goal is participation in a 10-workshop series, outcome goal appears to be business registration (which is not the same as business launch). How will participants gain hands-on business experience? How will this contribute to financial independence?
- Micro goal is participation in the business incubator, but how will participants reach the point that they are ready for this? Proposal missing detail on exactly how businesses will be launched and sustained, and what resources will be available to assist with this.
- Proposal references goal for youth to commence education toward career-based certification, and participation in paid internships/part time jobs – but proposal does not set these as goals for 2025 nor does it address how the program helps work toward these outcomes
- Budget does not include leveraged funds from YES Duluth to support work experience/internship wages, which is referenced in the proposal
- Trade Exchange element is great, and could be more clearly integrated into the program
- FFC is a critically important organization for our community, and they have some important components already in place but would benefit from significant technical assistance to improve the quality of their program, as well as oversight to ensure they are working toward and achieving outcomes
- Note that Workforce Development had provided a grant to FFC for this program, and ended up cancelling the contract due to lack of performance and follow-through on commitments

GND received CDBG funds in 2022, however, they did not meet all record keeping requirements or meet their goal. The goal was to assist 22 individuals, but by the end of the program year there was a total of 6 individuals assisted with job training. During the monitoring process, there was an insignificant amount of documentation for the tracking of individuals participating in the program.
