# 1. Call to Order and Introductions

• Vice-Chair Bowman called the meeting to order at 5:35 PM, introductions were made.

## 2. Approval of January 22, 2024 Annual Meeting Minutes

## 3. Public Comment

- Gabriel Peltier addressed the commission as a former Indigenous Commissioner in 2011. He has submitted an application to join the Commission again, with his primary goal to re-start the initiative for an Indigenous culture and arts center.
- A community member came to the Commission to let them know that there are a couple of Indigenous residents at Bethel who are not being allowed to smudge. Community members and city staff recalled that there was a similar issue in a County building several years ago and the Indigenous Commission assisted by writing a letting in support of the County allowing smudging. Vice-chair Bowman said they would like to confer with the Chair before going forward, but believes in the importance in supporting the Bethel residents' rights to practice their religion by smudging. The City Fire Marshall may be able to provide more information on local laws regarding fire code and the religious freedom to smudge.

- Duluth Public Arts Commission Commissioner Woods reported that DPAC has allocated \$15,000 of Arts Festival funding to the Indigenous Commission for the June Pow Wow., and \$15,000 for artistic Ojibwe language signage in City Hall. Commissioner Woods provided some updates on DPAC's current projects and goals. She invited the Indigenous Commissioners to attend future DPAC meetings so the two Commissions can stay informed of each other's work and support each other. DPAC meetings are typically held right before Indigenous Commission meetings from 4pm-5:30pm

• The Police Chief will be at the next meeting, and the Mayor has the IC schedule and will let city staff know what date will work for his schedule.

- June Pow Wow Planning Commissioners Villiard and Clark were absent, but are working on planning outside of the meetings. Updates expected at the March meeting.
- Honor Fires Gaagigewendodgosiwaj Honor Fires Commissioner Goodrich updated that this year is the third year of having these fires, with the support of City of Duluth, Mending the Sacred Hoop, Native Lives Matter Coalition. This year they would like to host fires in January, February, and May to coincide with MMIWR annual events. More information on these events was provided by Commissioner Goodrich is attached to the minutes. Babette Sandman plans to attend the March meeting to discuss other Honor Fires happening in the community.

Dear members of Duluth School Board:

On behalf of the Duluth Indigenous Commission, a few of us are concerned parents as well, with American Indian children in the Duluth Public Schools, we would like to take this opportunity to express our concern regarding the Resolution of Concurrence and Non-Concurrence pursuant to <u>Sec. 124D.78 MN Statutes</u>.

As you are aware, every year the American Indian Education Parent Advisory Committee (AIEPAC) is charged with completing a Resolution of Concurrence and Non-Concurrence. Every year, for many years, the AIEPAC committee has submitted a Resolution of *Non-Concurrence*. The American Indian student graduation rate is abysmal at roughly 46%. Even worse is the fact that graduation rates have been this low for decades. Why has this been normalized and accepted?

The Indigenous Commission wholly supports the following AIEPAC specific requests:

- **Reduce liaison caseload** currently the ratio of students to liaison is roughly 120/1. Best practices are a caseload of about 25/1. Hiring more staff would improve these numbers.
- Dedicate a permanent space for liaisons to meet with students. Currently, liaisons are stuck in closet spaces, small, shared spaces, and at least one is forced to use a rolling cart. Our students deserve better, which would include a safe private space and a culturally appropriate area to meet with the liaison.
- Create an action plan to retain and recruit American Indian staff to multiple roles.
- Create a school-within-a-school pilot project by working with American Indian staff and others in the community to provide more support and guidance for our students. The Indigenous Commission is very interested in this concept and recognize that doing what has always been done is not working. Radical ideas and changes are needed to drastically improve these numbers and help our kids succeed.
- **Provide robust professional development for district staff** that has been reviewed by American Indian staff.
