• Chair Villiard called the meeting to order at 5:52 PM

• Commissioner introductions were made for a member of the public who was new to the area. Chair Villiard explained the purpose of the commission.

    - City staff informed commission that a quote for Ojibwe language sign is in the works and they hope to have the quote by the next DPAC meeting.

# Smudging at Bethel

- Bethel does have a specific space for smudging.
- The commissioners talked about whether or not to have a representative from Bethel at the next Indigenous Commission meeting.
  - They agreed to let City staff know what they decide before next meeting.

## Indigenous Peoples' Day planning (October 14<sup>th</sup>)

- Commissioner Goodrich volunteered to help with planning.
- The Commission agreed to work off what was done last year, as there was a large turn out in 2023, and add to it for 2024.
  - They would like to put an emphasis on getting youth leaders involved this year.

- The Commissioners will make a list of prospective speakers before the September commission meeting.
- City staff reminded commissioners that the October Indigenous Commission meeting has been moved to October 7<sup>th</sup> so that it occurs before Indigenous Peoples' Day.
- The Commission would like Indigenous Peoples' Day to uplift local Indigenous artists.
  - They would like to find a local artist to create the poster art for the event poster.
  - Commissioner Goodrich thought that Native Lives Matter may be able to help with paying the artist up to \$250.

#### 7. Subcommittees

#### MMIWR –

- City of Duluth and City of Superior and law enforcement support was appreciated in 2024.
- Commissioner Goodrich reported that the report has been finished and the link will be sent out soon.
- A question was asked about the MMIWR license plates. Commissioner Goodrich reported that the money generated from the MMIWR plates goes into the State's reward fund.
- Commissioner Goodrich explained that the local grassroots initiative has a small pool of their own reward fund and would like to keep it that way to avoid having to always go through the bureaucracy of the State. With funds at the local organization level, the grassroots initiative can have an immediate "boots on the ground" approach when a new case arises. Having local money available helps fill the funding gap when local cases arise.

#### • Art in Gichi-ode' Akiing -

- Chair Villiard reported that tours have been taking place this summer.
- In response to periodic tagging of the murals in Gichi-ode' Akiing, Chair Villiard suggested that they could plan to host a community event to get people together to paint over the tagged area of the murals sometime soon. They could potentially paint more fish along the mural to discourage future tagging.
- Chair Villiard agreed to continue to send updates to the Commission via email after she has left.

#### • Education – No updates

#### Full Moon Ceremonies –

- Chair Villiard will reach out to Commissioner Davis and Roxanne about future ceremonies.
- Babbette is currently booking her full moon ceremonies at One Roof.

## • Housing -

 Commissioner Hrabik reported that they are prepping for the opening of Brewery Creek apartments, potentially September 1<sup>st</sup>.

- The HRA is subsidizing a portion of the apartments (32 units) at 30% of tenant income.
- Commissioner Hrabik also reported that the HRA is subsidizing 30 units at the future Wadena West housing development in West Duluth.
- Commissioner Goodrich voiced that she knows of many unhoused Native people who would like to stay in Duluth and are very interested in the Brewery Creek Apartments.

#### Ojibwe Language Pronunciation Guide and Signs in City Hall –

 Chair Villiard reported that the sound bite still need to be edited for the pronunciation guide. She might reach out to Zeitgeist for help with the editing process.

#### Sobriety Feast –

 Commissioner Goodrich notes that Sobriety Feasts are a great opportunity conduct community outreach. Future feasts would be a great place to share the news about new affordable housing projects.
