**1. Call to Order and Introductions**

- Chair Davis called the meeting to order at 5:30pm. Introductions were made around the room.

**4. City Reports and Updates**

- Board/Commission Liaison Updates
  - Duluth Public Arts Commission: Commissioners attempted to go to the DPAC meeting on 10/20/25, but there was no one in attendance. And Indigenous Commissions have attempted to find someone to communicate with about the funds and the project.
  - Commissioner Goodrich has been asking about the status of the grant fundings and the project.
    - Added comments to the previous minutes. Commissioner Goodrich stated that DPAC has already allocated money for the Indigenous Commission's art project. DPAC's minutes were also approved, and in their budget, it showed that the project money was allocated. The Commission would like a memo on the grant money that is earmarked for their project.

## 5. New Business

- **Recap of Indigenous Peoples Day event**  
- The Commissioners recapped that the work that was done for Indigenous People's Day. Commissioner Goodrich stated that it was the biggest turnout they ever had. Superior Mayor was in attendance, along with Superior High School Students. Harbor City High School students also showed up. Essentia Health Foundation in-kind donation for a port-a potty for the event. Tribal honor guard from Fond-Du-Lac was in attendance. 1854 Treaty tabled the event, along with Harm Reduction Sisters and CASDA. Art from Michelle DeFoe was present and was the featured artist and was sponsored by Native Lives Matter, through in-kind donation.  
-Commissioner Smith did Smudging of everyone. Human Rights Officer Marsha Lue stated that UMD students were in attendance, and appreciated being included at the round dance. She received a lot of good feedback. The whole event was youth led and was a great turnout. Enger Tower was also lit orange in celebration of the day at the request of the Indigenous Commission. Many community sponsors were in support. The Commission leverage their resources with no budget, and able to honor relatives. Babette Sandman was mentioned with her doing a lot of positive work on the Commission for many years.
- **Vote on whether to stay a Commission or become a subcommittee of the Human Rights Commission**  
The Commission asked to be presented with the proposal in writing. The proposal in tonight's agenda is the first time of the Commission seeing the physical proposal copy as of 10/20/25 from Councilor Awal. Commissioner Goodrich stated that at the last Councilor meeting on 10/9/25 she was in attendance. Chair Davis read the ordinance from Councilor Awal. Chair stated that the Commission has a unique perspective, and the work that they do is still being done despite being a small group. Commissioner Hrabik looked at the first sentence of the ordinance stating that the issues the Indigenous Commission deal with is not human rights issues. Chair Davis read the Respect for Distinct Identity and spoke on the "Risk of Dilution" which concerned diminishing of "consolidating all cultural and ethnic groups into one commission implies we are all one for the color of our skin".  
-Commissioner Goodrich also asked to add the mission statement from their bylaws to the "Respect for Distinct Identity", and also to add a link that shares the bylaws and the work/project that the Commission does. Chair Davis also read the ordinance to incorporate the Duluth Projected Class Commission.

Also, May 5<sup>th</sup> David Storbakken has recently gone missing he was last seen May 11<sup>th</sup>, 2025 in the Twin Cities. The Gaagige-Mikwendaagoziwag award fund is close to the \$10,000 goal . Continue to look for Sheila St. Clair, who has been missing over 10 years.

RE: AN ORDINANCE TO INCORPORATE THE DULUTH PROTECTED CLASS COMMISSIONS AS COMMITTEES WITHIN THE HUMAN RIGHTS COMMISSION AND FURTHER ALLOWING THE ADDITION OF OTHER COMMITTEES WITHIN THE HUMAN RIGHTS COMMISSION

At a regular meeting of the Duluth Indigenous Commission on October 20, 2025 Commissioners voted by consensus *Gegit (all)* to remain a sovereign Indigenous Commission. The Indigenous Commission was created by the Duluth City Council pursuant to Ordinance 9529, amending Chapter 2 of the Duluth City Code, 1959, as amended. The Commission serves in an advisory capacity to the City Council and Administration. The purpose of this commission is to ensure that the views of the Indigenous community are incorporated in the decision making, future planning, and stewardship of the city of Duluth. The commission will endeavor to act as a guide in the development of public policy, planning and services so that the Indigenous community is adequately represented in these processes. The commission will also endeavor to increase understanding and acceptance of the Indigenous community and culture and to increase Indigenous community involvement in all aspects of community affairs in Duluth.

**Sheila St Clair 10th year missing in Duluth MN.**

In Recognition of the 10th year of the Missing Sheila St Clair in the City of Duluth MN we are sharing the "first of its kind in the state of MN" and beyond reward fund that was created in Sheila St Clair's honor.
