- Review of 2018 claims and top health conditions
- Cancer
  - a. over 200 different types of diseases
  - b. Modifiable behaviors excess body weight and behaviors like smoking, tanning and low exercise contribute to 45% of new cancer cases and deaths yearly.
  - c. Prevention Cancer Management, Early Detection Impacting health outcomes
- Communication outreach and engagement HP proactively delivers relevant and personalized info to activate healthy and smart choices. Campaigns – Primary Care Provider, Pharmacy Price Transparancy, Compare costs & options, Breast Cancer Screening, Diabetes Support and Telemedicine.
- Orthopedics Identifying costs and opportunities Measure total cost index
- Piloting new technology using technology to communicate with younger population
- Second Opinion Services Janette will check on Retiree/Active population to see if they are receiving these services

#### Delta:

Heidi Anderson presented the Delta Annual Report.

- Review of 2018 plan
  - a. Total paid claims was \$826,207 for Jan Dec 2018
  - b. Members that had at least one cleaning 67.4 % down 2.6% from 2017.
  - c. 27% of members didn't see a dentist during the 2018 year more education needed to membership
