## Treasurer's Report:

Josh Bailey reviewed the financial statement for December 2023. It was noted that there could be a small variance as year-end numbers may still be processing. Health Plan revenues were over budget by \$553,918 or 1.69%. Health Plan expenses were under budget by \$6,091,059 or 17.29%. The Income Statement for Healthcare showed a reserve balance of \$16,014,128 of December 31, 2023. Dental showed a reserve of \$592,811 as of December 31, 2023.
