Duluth Joint Powers Enterprise Trust Board of Trustees Minutes Meeting Wednesday, January 15, 2025, at 11:00 am

David Montgomery called the meeting to order at 11:07 a.m. Introductions were made.

Approval of Minutes: Motion was made to approve September 18, 2024 minutes. Motion by Jill Keppers; seconded by Tom Werner. Approved.

Treasurer's Report:

Josh Bailey reviewed the financial statement for December 2024. Medical claims are up 20.87% and drug claims are up 15.08% compared to last year. Health Plan revenues and expenses combined report a favorable budget variance of \$586,947.59. The Income Statement for Healthcare showed a reserve balance of \$17,713,222 as of December 31, 2024. Dental showed a reserve of \$656,703 as of August 31, 2024.

New Business:

Jodi Elder (Brown & Brown) shared information on the Pre-Authorization change that began mid-year 2024.

- Carelon is the third-party vendor that provides pre-authorization management for Medica.
- Claims warrant care that are prescribed.
- Consistent with what other carriers are authorizing
- There seemed to be a lack of communication and awareness as the new program was rolled out mid-year.
- Gather more data and the process may be updated
- There is not a total denial of care, just seems to be delays
- This process puts more burden on the employee as there is a significant disruption to immediate needs.
- Sometimes there is the cost of two deductibles due to the delays adding more cost to the self-insured plan.
- Contract ends with Medica this year The RFP will begin in the next couple month with a presentation likely to take place summer of 2025.
- Reference point with new carriers could include Pre-Authorization program
- March 19 JPE meeting will review the health plan analytics and provide a timeline/overview for the health plan marketing process.

Wellness Report:

- January 10, 2025 the new Wellness Program rolled out to most employees
- Application that Medica uses is Personify Health
- Various Resources that members can access includes point total, Wellness Challenges, Steps using tracking devices
