DULUTH PUBLIC UTILITIES COMMISSION Meeting Minutes February 16, 2016

Call to Order: The meeting was called to order at 5:16 p.m. by President Prusak.

Approval of previous meeting minutes

Old business:

16PUC-002 - RESOLUTION OF THE DULUTH PUBLIC UTILITIES COMMISSION RECOMMENDING THAT THE CITY OF DULUTH AMEND SECTION 48-27 OF THE CITY CODE AUTHORIZNG AUGMENTED CHARGES FOR UNAUTHORIZED TURNING ON OF WATER OR GAS SERVICE. (revised)

16-0Valve O - AN ORDINANCE AUTHORIZING A PENALTY FOR UNAUTHORIZED TURNING ON OF WATER OR GAS SERVICE AMENDING SECTION 48-27 OF THE DULUTH CITY CODE, 1959, AS AMENDED. (revised)

After Bob Asleson gave a brief explanation of the reasoning for the proposed penalty, Commissioner Sipress motioned to approve the revised version of resolution 16PUC-002 and the resolution was approved unanimously.

Water utility discussion

Eric Shaffer provided a list and gave a brief summary of capital projects that could be done in the next 5 years if there was a 6% rate increase. After staff and commissioners discussed the cost of water main breaks, debt service, and various other utility expenses, commissioners directed staff to bring a 6% rate increase resolution to the March meeting. A public hearing will be held at the beginning of that meeting.

New business:

16PUC-003 - RESOLUTION SEEKING TO PROVIDE A SUSTAINABLE ALTERNATIVE TO STORMWATER MANAGEMENT AND THEREBY REDUCE IMPERVIOUS SURFACE DEVELOPMENT IN SENSITIVE AREAS ALONG DULUTH'S TROUT STREAMS SO AS TO IMPROVE WATER QUALITY AND REDUCE NEGATIVE IMPACTS OF FLOODING. (Sellner)

Commissioner Sellner explained the intent of this resolution and, after some discussion, most commissioners agreed with that intent. Commissioner Sipress suggested that councilors and staff should consider the issue and work out the details before this is officially brought to City Council. Commissioner Sipress motioned to approve 16PUC-003 and the resolution was approved unanimously.

Updates from staff

Jim Benning mentioned that the year-end adjustment from WLSSD resulted in a very small decrease. Residential sanitary sewer rates will remain the same. Commercial rates will decrease by \$0.01.

Upcoming Council actions

Jim Benning mentioned a resolution contracting with LHB to finalize the plans for the next phase of the lift bridge project, a resolution awarding the Campus Connector project for \$770K, a resolution to purchase water pipe for the 4th Street project, an agreement with the railroad to put a water main underneath the tracks, and the second reading of the ordinance adopting the State's cold weather rule.

Commissioner questions or comments

Commissioner Sellner mentioned the second reading of an ordinance modifying DPUC commissioner terms. Jim Benning stated that this change was approved by the DPUC in 2012, but it never went to Council. Resolution 12PUC-001 was made available to commissioners. Commissioner Sellner suggested extending the limit to three terms instead of two.

Commissioner Sipress would like to meet with Jim Benning, Eric Shaffer, and Keith Hamre to discuss the tax-forfeit parcels issue and the resolution that was just passed.

Vice President Thorsell inquired about the Superior Street project. Commissioner Sipress answered that the project is from 6th Avenue W to 4th Avenue E.

Preview of upcoming business

The next regular meeting is scheduled for Tuesday, March 15, 2016, at 5:15 p.m. in City Council Chambers. Staff will prepare a water rate resolution as directed by the Commission. A public hearing will be held at the March meeting for this proposed water rate resolution. President Prusak mentioned the possibility of holding the May meeting at the Lakewood Treatment Plant.

RESOLUTION NO. 16PUC-004

RESOLUTION ESTABLISHING WATER RATES EFFECTIVE WITH METER READINGS AFTER APRIL 30, 2016; SUPERSEDING ALL PRIOR INCONSISTENT OR CONFLICTING RATES AS OF MAY 1, 2016.

RESOLVED by the Duluth Public Utilities Commission (the "Commission") that the Commission hereby makes the following Finds of Fact:

- 1.) The City's water utility system infrastructure, taken as a whole, is badly deteriorated and much of it needs to be replaced.
- 2.) A large part of the City's water utility system infrastructure is in excess of 80 years old or more and has exceeded its expected useful life.
- 3.) At least \$4 Million needs to be invested annually in water-related capital projects in order to maintain the system's ability to serve the needs of the City over the long term.
- 4.) The City's water booster stations and water treatment facilities will need \$8 Million for repairs and replacement of equipment over the next 10 years to meet the needs of the City.
- 5.) The City has not increased its water rates since January 2013.
- 6.) Because of the deteriorated state of the City's water mains, the utility has suffered increased costs for repair related to water main breaks as well as losses of product and revenues.
- 7.) It is necessary to increase water rates charged by the City to provide funds for the needed upgrading and improving of the City's water distribution system.

FURTHER RESOLVED, that effective with the water meter readings after April 30, 2016, the rates to be charged to all customers of the water utility of the city of Duluth shall be amended as follows:

STATEMENT OF PURPOSE:

This resolution sets water rates effective with meter readings after April 30, 2016.

This resolution represents a rate increase of approximately 6% over those applicable after January 1, 2013. This increase will provide an estimated \$715,000 annually in additional revenue for capital improvements, raising the total funds available for capital projects to an estimated \$3,500,000.

Subject: 2015 Wastewater Treatment Year-End Adjustments

Dear Mr. Benning:

At the close of each year, we notify our wastewater treatment users of the year-end adjustment based on the actual flow and load data, and treatment costs.

For 2015, the WLSSD Board has approved total wastewater charges of \$26,810,145 as shown in the attached comparison of billed (budget) to required charges (actual) for 2015. Each wastewater user will receive additional charges or credits based upon their actual flows and loads as compared to budget. This amount will be spread evenly over the 12-month period in 2016.

Attached is a table summarizing the 2015 billing as compared to the 2015 required actual. For Duluth the total year-end adjustment for 2015 is a charge of \$96,638 due to higher daily BOD and peak flow as compared to budget. This will be included as a \$7,803/month charge on your 2016 monthly billing.
