- a. Reported on crime trends. Shared summary data comparing 2012 and 2013. For 2013, the DPD exceeded 100,000 calls for service, a 10% increase from 2012. Opiate epidemic seems to be fueling a lot of thefts.
- b. Deputy Chief Roeser shared responses to some questions from Community Forum:
 Racial Make-up of Traffic Stops: Only keep statistics on arrests, not just traffic stops.
 Consistency of Policing Techniques: Expectations are the same across neighborhood
 In-service training provided to all of new hires; Professor from St. Cloud Training that covers
 police culture and cultural sensitivities; Have had different groups of people get sent to class
 – try to have some folks from the department that attend.
