Police Liaison Report:

Mounted Patrol : Officers Amber Peterson and Jim Matson two of three officers, training background, afternoon and evenings, bar closings, last year over 5000 non-enforcement contacts, wear body cameras, Community events,

Crime Update: Lt. Marquardt provided DPD handouts and snapshots. She said an internal audit currently is underway for “use of force.”

Personnel complaints: Lt Marquardt reviewed status of current complaints.

Other: DPD is starting burglary training for identifying trends and suspect profiles. Pilot project will be in east Duluth neighborhoods. Update on Crisis intervention training. Will be here in October for first group of patrol officers. Training is based on the Memphis model.

- **Presentation Committee:** Report by Bowen-Bailey: **Case Review:** We discussed the possibility of doing a case review on the Jouppi/Jackson case. Next Open Forum: Chief Ramsay is planning on doing a series of conversations around the city related to the Presidential Task Force on 21st Century Policing Report.
