## **Updates:**

- Skills based hiring workshop for employers
  - o June 17, 9:00 a.m.-1:00 p.m.
  - Government Services Building
- WIOA Impact Report

- o Top level summary report on impact of our federal grants
- 551 people served through WIOA Youth, Adult, and Dislocated Worker grants and Wagner-Peyser (Job Service) in Program Year 2023 (July 1, 2023-June 30, 2024)
- o 70% employed, \$42,860 estimated average annual earnings per person
- Economic Impact, \$16,543,834 total estimated annual earnings for all employed
- State and federal legislative updates
  - State funding
    - State has not finished so we will probably be moving into a special session
    - Overall cut to the workforce portion of the omnibus bill is \$30 million, with cuts across the board to programs
    - We've been working to protect the workforce development fund, and want to be sure we have healthy reserves to serve dislocated workers and other programs
    - State funding will be less, but do not know how much less
  - Federal funding
    - Over this weekend, the "Big Beautiful Bill" passed in the House Budget Committee which includes work requirements for Medicaid, cuts to adult education, SCSEP program eliminated, cuts to WIOA
      - Congress needs to pass a budget by the end of September, or the government shuts down
      - MN Association of Workforce Boards is engaging daily with federal lobbyists who work
        with workforce organizations around the country, and they're getting together with
        other state workforce associations for advocacy. There's a group flying to Washington
        DC in June to discuss the importance of WIOA and workforce funding.
      - Elena Foshay is requesting letters from those representing the business community about the importance of workforce programs – template will be shared
      - Federal funding cut impacts are not seen in NE MN yet, however we expect to see an increase in UI in fall
        - EPA, some layoffs so far, lab may be closed
        - Mining layoffs just began
- MAWB Summer meeting
  - o August 13-15 in Duluth
  - All board members invited to attend
  - o Agenda will be shared once available

#### Good news:

- True North Goodwill new site update
  - \$22 million headquarters, Atlas Park, groundbreaking this summer
  - Able to serve more clients with less space
  - Will have daycare for clients on site
  - Current Garfield Avenue location is for sale

- Career Pathway Training graduations
  - o CNA class, 8 graduates in April
  - o CNA class, 10 graduates in May
  - Millwrights Union graduated 13 out of 15 enrolled in pre-apprenticeship training
  - Building Strong Communities construction class, 9 graduates
  - o Job Fair for City Summer Temp Jobs, Yes Duluth participants hired
- 11 SCSEP participants found jobs

### YES Duluth (Youth Employment Services) program presentation

- Open to Duluth residents, ages 14-24
- Offers education and training, employment services, support services
- Eligibility factors vary with each grant
- Funding-federal, state, YouthPrise (state)
- Work in schools and community
- YouthPrise Duluth Direct Cash Pilot
  - o 2-year pilot, for unhoused youth, 35 participants
  - o \$1000 a month, plus a one-time \$3000 payment
  - Monthly survey to collect data
  - Areas of Impact
    - Housing, financial wellness, transportation, food security, education
    - Financial literacy learning circle

#### **Customer survey data summary and discussion**

- Data gathered Feb-May 2025
- Survey sent out through partner organizations, social media, and available to in-person customers on paper and online
- 57 responses, plus 139 responses through MFIP survey
- Findings with 57 responses: people who used our services would recommend us to others, job search is the number one reason people visit, job fairs valued
- Findings including the 139 responses through MFIP survey: people prefer to be served in-person but want
  flexible options, having a centrally located office is <u>very</u> important, people prefer regular daytime hours, and
  would like to be contacted by email or text message
