2023 MN Legislative Session: Climate and Energy Policy Updates – Sheri Hansen, JD, ARP (Director of Communications, Advocacy, and Public Outreach; AIA Minnesota)

- AIA Minnesota Overview: American Institute of Architects
 - o 2,300 design professionals from around the state
 - Climate action is primary focus; built environment can produce as much as 40% of carbon emissions; low-hanging fruit
 - o Contract lobbyist, staff, member volunteers (education for legislators), coalitions
- 2023 Advocacy Environment
 - Unique opportunities: DFL control of all 3 arms, \$17bn surplus, IRA and IIJA funding, extraordinary legislative activity
- Key Bills Passed in 2023
 - 100% carbon-free energy by 2040

- GHG reduction goals: many substitutes/off-ramps for utilities to make goals attainable
 - 50% by 2030
 - Zero by 2050
- Climate action grants to cities- run through MPCA, can address climate (mitigation) or resilience (adaptation) or both; 50% match
- o Increased funding for Clean Energy Resource Teams (CERTs) to assist cities
- Infrastructure Resilience Advisory Task Force
 - State agency leadership, members from both House and Senate, municipal organization representatives, trades, Tribal representatives
 - Must meet by October 2023, present strategic recommendations by February 2024
- Federal climate/energy response (staffing) at MBB to administer new State programs as well as IRA and IIJA
- Commercial building energy benchmarking
 - Question who maintains the program? Commissioner of Commerce
 - Bill 216C.331
 - Buildings over 50k sq. ft. must report beginning in 2025
- o Added resilience and weather trend considerations to sustainability programs
- Residential heat pump grant program
- o Green bank established: \$20M, onetime allocation
 - Loans for clean and renewable energy jobs, in areas with establish environmental justice concerns
- Building Codes
 - AIA position: current building codes process works by considering cost, taking national and international programs and applying a Minnesota lens, a non-politicized code that is driven by expertise, should preserve
 - Accelerated commercial energy code: can now be done in 3 years rather than 6; energy codes are moving, and at a faster rate
 - Technical Advisory Group working on EV charging infrastructure policy/mandate recommendations for large multifamily, commercial, and public buildings having more
 - Refrigerants allowed for use: MN now to follow EPA guidelines rather than specific MN list
 - Question just focusing on electrification, or getting away from fossil fuels? AIA will be promoting getting away from fossil fuels, mechanical systems analysis/evaluation may focus on fossil fuels
- Municipal utilities included in carbon-free/renewable standards
- \$115M state fund for energy competitiveness grants
- MN Climate Innovation Finance Authority

- Rep. Liz Olson: Chair of Ways and Means Committee, authored/co-authored many bills for Duluth area, authority of GHG emissions reduction goal amendment and utility renewable energy obligations modification
 - Center for Sustainable Building Research has more information on the utility renewable energy obligations modification
- Rep. Alicia Kozlowski: on Capital Investment, Labor, and Economic Development Committees, authored bill to fund support for tribes on energy policy, coauthored green infrastructure program
- Sen. Jennifer McEwen: Chair of Labor committee, Vice-Chair of Environment, Climate Legacy, member of Energy, Utilities, Environment, and Climate committee, authored local government climate action grants, CERTs teams additional funding, etc.

- New team members: Brett Crecelius (Community Resilience Project Coordinator), Violet Forster (new UMD Intern, working on office timeline)
- C-SAT: Now has 18 members from 11 departments
- Carbon Disclosure Project reporting completed; public-facing way to report emissions, score pending, part of Race to Zero
- Housing Trust Fund Review Committee voted to incorporate incentives to participate in MN Power Conversation Programs (following recommendations from the American Council for an Energy Efficient Economy)
- E-Bikes: DPD received 6 e-bikes with gap funding from the Sustainability Fund (increases reach, community policing benefits, decreases municipal vehicle emissions)

RACER Grant Updates – Brett Crecelius (Community Resilience Project Coordinator)

- Federal grant from the Department of Energy Solar Energy Technologies Office (SETO)
- Duluth the only municipality awarded funds
- Community Research: UMN independent contracts and Ecolibrium3
 - Determine emergency response needs and resilience requirements
- Site Analysis: City of Duluth
 - Evaluate and prioritize sites for multiple criteria
- Goals and Objectives
 - o Development of a replicable model for other cold-climate communities
 - o Address functional resilience needs via solar and storage deployment

City Energy Updates - Mike LeBeau

- Biggest project: City Hall HVAC project, replacement of old systems
 - o Ahead of schedule
- Working to add resilience and energy efficiency in all projects
