Accessible Parking Update

- August 1 meeting: accessible parking zones approved:
 - o 110 S 67th Ave W
 - o 7 E. 6th Street
 - A request from the developer of the old Ordean Building proposed that the two
 accessible zones on Michigan Street be turned into a two-stall loading zone and
 that the metered stall be converted to a four-hour accessible zone. Approved.
- Upcoming Sept 5 meeting: accessible parking zones recommended for approval:
 - 4428 W. 8th Street
 - o Accessible parking needs were identified with the redevelopment of 6th Ave. E:
 - 902 N 6th Ave. E. Temp accessible parking on 9th street. Proposing a permanent zone on 6th Ave E. once project is complete.
 - 521 E. 10th Street.
