I. <u>Call to Order</u>

Chair David Woodward called to order the meeting of the Heritage Preservation Commission (HPC) at 2:08 p.m. on **Monday**, Feb 22, 2016.

II. Public Hearings

III. Unfinished Business

A. St. Peter's Church Historic Nomination –City Council is considering the Historic Nomination Ordinance #16-011 at their 2/22/16 and 3/14/16 Meetings. Chair Woodward would like to see a few changes to their preservation plan. He wants to make sure they are eligible for future financing. He'd like to change the verbiage under materials and details of hand-cut stone to match the original materials and take out the word "impossibility". Under the section of the plan which pertains to signs and accessories, lighting - he would like to add "no back lit signs". He also suggests getting rid of the economically feasible caveats. Under the windows and doors section, Kristi Johnson doesn't agree with infilling of the windows and would like to take out the exception of unless economic necessity is presented. Chair Woodward notes other items where economic necessity is listed and thinks it should be at the beginning of the document as a general rule. He would like to see a list of contributing elements/areas to be preserved, for example exterior facades. Johnson notes all four exterior building facades are included in the areas to be preserved. She suggests photographs be included with notations of what makes them special identified. Mike Poupore agrees to work on the notation. Johnson asked when they need to vote on the preservation plan. Per Robertson the 2nd reading is on March 14, 2016. Johnson said they could approve with the changes specified above.

MOTION/Second: Johnson/Woodward approve the preservation plan with the changes specified above.

Lincoln Park Restoration and other Potential Parks Nominations – Chair Woodward would like to nominate two parks for local landmark designation legacy grants. He would like to target Lincoln Park and one other. It would be similar to JJ Astor Park grant. He would like to see the parks department on board. Enger and Congdon are mentioned. Chair Woodward asks Steven Robertson if he could get clarification from parks if they are still on board. Robertson agrees.

- B. Potential Nominations: Peoples College, Riverside City Water intake station, other city waterworks facilities and remaining ex-city fire halls. (Table until next time.)

He would like to invite city staff to attend including the following departments: maintenance, parks, and planning. Chair Woodward would like to come up with a thumbnail sketch of the topics to be discussed. Robertson suggests including a segment on how local and national landmark designation could benefit owners (i.e. tax credits).
