Heritage Preservation Commission November 25, 2014 Meeting Minutes Room 303 – Duluth City Hall

### I. Call to Order

Chairperson David Woodward called to order the meeting of the Heritage Preservation Commission (HPC) at 2:00 p.m. on Tuesday, November 25, 2014.

### II. Annual Meeting

- B. Review calendar for 2015 meetings, and general goals for 2015.

  Patricia Mullins will no longer be on the Planning Commission or the HPC as of March 2015.

Goals for commission for next year: Patricia Mullins notes tourism as she would like to see the gathering stories of Duluth's history for tours (both walking driving tours). Chair Woodward asks how the HPC can better serve the needs of the community. He would like to see a city-wide heritage preservation plan that he hopes to work on next year. Laurie Boche mentions the future summit. She thinks it can be separated into two groups: one catering to professionals and one to the community as a whole. Chair Woodward would like city staff from other areas (including community development) to be invited to the summit workshops. Chuck Froseth also would like to include the other communities such as Hermantown, since we are tied together as a community. Chair Woodward also would like to include the tribal communities. This summit could help build good public relations within the community. Chair Woodward asks for the summit discussion to be included on January's meeting agenda.
