- 2. Acceptance of June Meeting Minutes
 - a. Commissioner Islas moved to approve June minutes, seconded by Vice Chair Harris.
- 3. Public comments
 - a. None at this time.
- 4. Guest speaker Duluth Police Department
 - a. Duluth Police Chief Mike Ceynowa was invited by the Commission to speak on Duluth Police Department's (DPD) involvement with Immigration and Customs Enforcement (ICE).
 - Chief Ceynowa reiterated that DPD does not work in immigration enforcement and is not authorized to serve as immigration enforcement. There is a DPD policy manual on their website that includes their policy on immigration on page 75, which was written in 2016 with the Interfaith Committee for Migrant Justice.
 - ii. DPD would get involved in these actions only if asked to provide security at an event or large-scale ICE operation to provide protections between possible protestors and ICE. In such situations, DPD would still not be taking any enforcement action.
 - b. Discussion with community members.
 - i. Chief Cenynowa addressed questions and concerns regarding law enforcement identifying themselves, records kept locally, and his lack of ability to track where people are after being detained by ICE. People who see ICE activity and have concerns can ask DPD if they have any

information. DPD does not house inmates for ICE. Community members who have questions are encouraged to call the DPD main office (730-5020), where the call will be directed to Chief Ceynowa or other staff.

 - i. The MN Department of Human Rights budget passed with bipartisan support for the next two years.

 - iv. Hoping to have other meetings to convene statewide Human Rights commissions in the future.
