- 1. Call to Order and Introductions
 - a. Meeting called to order at 5:33 p.m. by Chair Nomi Ostrander

- 2. Presentation on suspension rates ISD 709
 - a. ISD 709 presented on school suspension rates, see attached presentation.
 - b. Prevention & Response Summary: ISD 709 is in their 4th year of implementing Minnesota Multi-tiered System of Supports (MnMTSS), which moves from universal support practices to individualized support. Chair Ostrander brought up concerns about support for students from immigrant families given the increased capacity of ICE. ISD 709 said they want limited impact on families and students and want all to feel welcomed and supported. For ICE to access students, they must have a proper judicial warrant and follow proper legal procedures. They do not currently offer remote education options for students impacted by concerns over deportation.
 - c. In conclusion, ISD 709 noted this is the only time they present this data, though they have continual internal conversations. They noted school board meetings are all recorded, with agendas and recordings available online for the community to understand what conversations are taking place within the district.

 - ii. MN Council on Disability Director will be in Duluth to do workshops. A general ADA workshop open to the general public will be held at Lake Superior College on September 22nd from 10:30 a.m. to noon.
